Executive summary

The annual North Atlantic Health Sciences Libraries (NAHSL) chapter conference took place in October. The conference was held in Woodstock, Vermont. The following NER related events took place:

- A Resource Library Directors' meeting was held
- A Hospital Library Subcommittee meeting was held
- The Hospital Library Subcommittee performed an instructional play on evidence based nursing
- A DOCLINE/EFTS open forum was held
- An RML Update was given at the membership business meeting
- The Consumer Health Coordinator taught classes on: Complementary and Alternative Medicine (co-taught) Proposal Writing for Funded Projects

While RAC-related meetings took place at the NAHSL chapter conference, a full-RAC meeting was held this quarter in August. NER staff presented on their respective program areas and solicited feedback. The Education and Training Working Group assisted in the completion and reporting of the education and training needs assessment conducted in the previous quarter.

The subcontract proposal period was initiated. A Request for Proposals for competitive outreach projects was announced. Proposals were submitted and are under review by NER and the Outreach Review Subcommittee. The targeted proposal from Tufts University was forwarded to NLM for approval. Smaller funded outreach projects are under way.

Across the region and at venues at the combined chapter meeting, staff conducted sixteen presentations to 276 participants. In addition to the presentations conducted in conjunction with the chapter conference, these sessions included topics such as PubMed, consumer health, DOCLINE, and evidence-based public health resources

In June Donna Berryman announced her intention to resign her position as Outreach and Education Coordinator. Donna's last day was August 3rd. Donna began her position in the fall of 2001. As Education and Outreach Coordinator Donna provided instruction to librarians, physicians, nurses, pharmacologists, consumers, administrators, health policy specialists, teachers, students, on PubMed, TOXNET, NLM Gateway, and other NLM resources. Donna developed many classes including an introductory course for librarians in the use of NCBI's molecular biology information tools. Donna coordinated NER's national and regional exhibiting activities, logging many 'booth hours'. Donna accepted a position the University of Rochester's Edward G. Miner Library.

A quarterly edition of the NN/LM—NER newsletter, the NER'eastah, was issued online.

Three extended DOCLINE training sessions were held with individual members throughout the quarter. Two sessions were part of an ongoing series of sessions to the InRhodes Resource Center in Rhode Island. DOCLINE training sessions are conducted via telephone and Internet connections. A larger DOCLINE Update meeting was held at the NAHSL Chapter Conference. The Update gathers interested members to brief DOCLINE users and solicits Feedback. The session is shared with the EFTS Program Coordinator and QuickDoc Coordinator. Over fifty people attended the one-hour session.

Regional Advisory Council (RAC) activities and needs assessment and evaluation activities/data

<u>Full Regional Advisory Council</u> The full RAC was convened on August 9th. Attendees included members previously convened from last year's meeting as well as other network members who have participated in RAC related activities throughout the year (principally the Education and Training Assessment). The RAC meeting was an opportunity for NER staff to brief members on the full scope of NER programs: Resource Sharing, Education, Consumer Health, Public Health, Awards and Subcontracts, and Exhibiting. After the full overview, staff presented current plans for program assessments to be conducted in the coming calendar year. A briefing of the ongoing work in emergency preparedness was also presented. The completed assessment on for Education and Training was presented by a member participant. RAC members provided feedback on both program overview and assessment presentations and the emergency preparedness briefing. Future work on program assessments will have the participation of the program area's respective RAC Working Groups or Subcommittee. Twenty-two members attended the RAC meeting.

<u>Hospital Library Subcommittee(HLS)</u> The HLS met several times this quarter and is working on several initiatives. The Subcommittee met via teleconference on August 17 and met October 27 during the NAHSL Chapter Conference. Ongoing issues include

follow-up on the previous release of the hospital library toolkits, promoting evidence-based nursing through an instructional play, and accreditation standards for Massachusetts. Several members of the HLS have been meeting with the Massachusetts Medical Society to include library services in the Society's Accreditation Standards document. This work is ongoing.

The Subcommittee performed a play written by a New England hospital librarian. The play "Nursing Practice Court" was performed in the town courthouse Woodstock, VT, where the NAHSL chapter conference was held. Over 100 conference participants attended the staging including the Medical Library Association's Carla Funk.

Resource Library Directors The Resource Library Directors were convened at the NAHSL Chapter Conference October 28th. Library Directors were briefed on the ongoing developments of the Emergency Preparedness national collaboration. NER coordinators and directors provided an overview of each program area in addition to ongoing assessment plans. The meeting also provided a forum for all directors to brief each other on current issues and events occurring at their respective institutions.

<u>Outreach Review Subcommittee</u> The Outreach Review Subcommittee was notified of the NER RFP to be released. The Subcommittee was informed of the timeline and the review process. Four members contacted from the previous year were available to serve again as reviewers.

Outreach

No new funded projects were awarded or subcontracted for the project. NER issued its Request for Proposals for health information outreach projects in August with an October 17 deadline. Several inquiries were made by network members regarding institutional eligibility. Proposals were submitted to NER from three institutions. Proposals were forwarded to the RAC's Outreach Review Subcommittee for comments and scoring.

<u>Update of ongoing major projects (funded at ≥ \$15,000)</u>

Four subcontracts are currently in early phases of operation. The projects were approved in Year One and are in their early phases of initial meetings and equipment purchases. Below are project descriptions.

Littleton Regional Hospital, Gale Medical Library, Northern New Hampshire Health Information Outreach will conduct a pilot project at three sites in northern New Hampshire that do not have convenient (if any) access to health sciences library services: Cottage Hospital in Woodsville, NH, Indian Stream Health Center in Colebrook, NH, and the Morrison in Whitefield, NH. The primary goal of this project is so that Health professionals at rural health care facilitated in the northern New Hampshire will have regular access to health information resources in order to provide high quality care.

Treadwell Library at Massachusetts General Hospital will establish an onsite Health Information Resource Center at the CAPIC (Community Action Programs, Inter City, Inc.) Head Start Program in Chelsea, MA. CAPIC Head Start serves low-income families with young children in Chelsea, Revere, and Winthrop. Many families are recent immigrants. The Project team will create a physical resource room and a web site containing resources on general child health and wellness, nutrition and healthy eating. The Project team will teach parents and Head Start staff how to find and use appropriate and authoritative health information.

University of Vermont Connecting Patients, Providers, and the Community with Quality Health Information: This project will assess the use of consumer health information in a clinical setting located in a rural, and economically disadvantaged community. Dana Medical Library will team with medical and professional staff of the Milton Family Practice to provide educational modules on quality patient and consumer health sources. The partners will also enhance the ability of the Milton Public Library and the Milton Family Community Center to support the health information needs of the community.

Yale University's Information Needs of Connecticut School Nurses: This project is designed to determine the information needs of Connecticut school nurses and to develop resources and training that match those needs. The information needs of the school nurse population have not been reported in the literature, and it is therefore assumed that it is an understudied area. The project will center on the use of a survey as well as focus groups as the main tools to discover how school nurses currently find new information, what their needs are, and what would be the most helpful way for them to access information in the future. Results of the data collection will be analyzed to develop a strategy of information delivery and potential training opportunities
