Nuclear Expert Background: I am an Engineering graduate of both UCLA (BS in Nuclear and Mechanical Engineering in 1966) and USC (Masters of Mechanical Engineering in 1970). I am a retired Professional Engineer in both Nuclear and Mechanical Engineering from California. I worked for the Los Angeles Department of Water and Power (LADWP) in their Power Design and Construction Division for 30 years before retiring in 1995 and moving to Nevada in 1997. During my early career at LADWP, I was the Federal Siting and Licensing Engineer for Nuclear Power Plants. As one of my assignments, I sited and obtain a Site License for the San Joaquin Nuclear Project which was to have four 1200 Mwe Nuclear Units in Kern County, California. This was a joint venture by all the major Power Utilities in California with LADWP as the Project Manager. For \$25 Million, we successfully obtained the Early Site approval by the ACRS in 1979 which was allowed by the modified Federal legislation on the NRC licensing process.

I am also the screenwriter for Civil War II©, a pro-Nuclear full length adventure movie (Soon to go into Production after the next rewrite which is part of the normal movie development process.) against the shipping of high-level Nuclear Waste Cores to Nevada against the State of Nevada's objections and against the U.S. Constitution! Professional Expert Nuclear Siting Recommendations:

1. DOE Management SHALL immediate order all work on Yucca Mountain STOPPED and the Project Moth Balled!!!
2. DOE Management SHALL immediately inform the President and Congress that further forcing Yucca Mountain onto the Citizens of Nevada with all the technical storage and National Transportation issues (Transporting Whole Core elements) is not a winning proposition.
