- **5) H.R. 289** To expand the boundaries of the Ottawa National Wildlife Refuge Complex and the Detroit River International Wildlife Refuge (Kaptur/Dingell Resources)

BILL SUMMARY AND KEY ISSUES

Motion to go to Conference on H.Con.Res. 95 – Concurrent Resolution on the Budget for FY2004. The House will consider a motion to go to conference on H.Con.Res. 95, which was adopted by the House on March 20th (the Senate approved its version of the Budget Resolution on March 26th). Mr. Spratt, Ranking Member of the Budget Committee, will offer a Motion to Instruct Conferees to: reject House Republicans' cuts to Medicaid and Medicare; reject House Republicans' cuts of \$9.4 billion to key education programs; reject House Republicans' \$14.6 billion cuts in Veterans' benefits; reject House Republicans' cuts to railroad retirees' pensions; reject House Republicans' \$61.5 billion cut in aid for working families and the disabled; and reject House Republicans' cuts of \$18.6 billion to agriculture programs, in a deficit neutral way.

Democrats are strongly urged to VOTE YES on the Spratt Motion to Instruct.
