## Open Discussion About Outreach and RAC Involvement September 10, 2007

The following points were mentioned in response to issues related to community outreach and ways that RAC members can assist the GMR staff in planning and evaluation:

- CBOs: don't leave medical libraries out in planning health information services
- Med/health science libraries: need to balance
- Nurse educators: good target population
- Chicago Public Library (CPL) and University of Chicago: Disease-specific programs
- Public library outreach at exhibits: reach other exhibitors
- NLM: MedlinePlus (does not) have all the answers
- Outreach: not health information but how to find and pay for services
- Nurse educators: need free online stuff; don't have time to go to library to get articles
- MedlinePlus is responsive to feedback
- Commercial resources
- North Dakota nurse association: outreach to professional organizations Wisconsin nurse association: exhibiting and student nurse association
- Hoosier science teachers: an outreach benefit to health science libraries
- Need win-win for health science libraries and consumers/health science librarians
- Ohio: dichotomy between CBO administrators and health science librarians
- Consumer health libraries are not necessarily associated with the health science libraries
- Public relations base vs. health information base
- Question different benchmarks for CBOs and health science libraries?
- Different way of measuring value of service?
- Larger academic institutions → increased community outreach
- Patient is driving healthcare now more than physician
