| 18 | (b) Condition of Conveyance.—The conveyance                 |

| 21 | subsection in its condition at the time of the conveyance,  |
| 22 | commonly known as conveyance "as is".                       |
| 23 | (c) Description of Property.—The exact acreage              |
| 24 | and legal description of the real property to be conveyed   |

- 3 (d) Additional Terms and Conditions.—The
