(Granted under the authority of Sect ion 203 of the U.S. International Emergency Economic Powers Act (50 U.S.C. § 1702), Section 5 of the United Nations Participation Act (22 U.S.C. § 287c), Executive Orders No. 12722 of August 2, 1990 and No. 12724 of August 9, 1990, and Parts 501 and 575 of Title 31 of the Code of Federal Regulations.)

1. The transactions and activities delineated on the reverse hereof are hereby authorized.

2. This license is granted upon the statements and representations made in the Application, otherwise filed with or made to the Treasury Department as a supplement to the Appl ication, or based on information available to the Treasury Department, and is subject to the condition, among others, that all parties to the License comply with all regulations, rulings, orders, and instructions issued by the U.S. Secr etary of the Treasury under the authority of Section 203 of the International Emergency Economic Powers Act, Section 5 of the United Nations Pa rticipation Act, and the terms of this license.

3. The Licensee(s) shall furnish and make available for inspection any relevant information, records or reports requested by the U.S. Secretary of the Treasury or any duly authorized officer or agency.

4. This license expires upon the com pletion of the authorized transaction, is not transferable, and is subject to the terms of Executive Orders No. 12722 and 12724, and any regulations, rulings, orders and instructions iss ued pursuant thereto, and may be revoked or modified at any time at the discretion of the U.S. Secretary of the Treasury. If this license was issued as a result of willful misrepresentation on the part of the applicant, it may, at the di scretion of the U.S. Secretary of the Treasury, be declared void from the date of its issuance, or from any other date.

This license does not excuse compliance with any law or regulation administered by the Office of Foreign Assets Control or any other agency (including reporting requirements) ap plicable to the transaction(s) herein licensed, nor does it release Licensee(s) or third parties from civil or criminal liability for violation of any law or regulation.
