

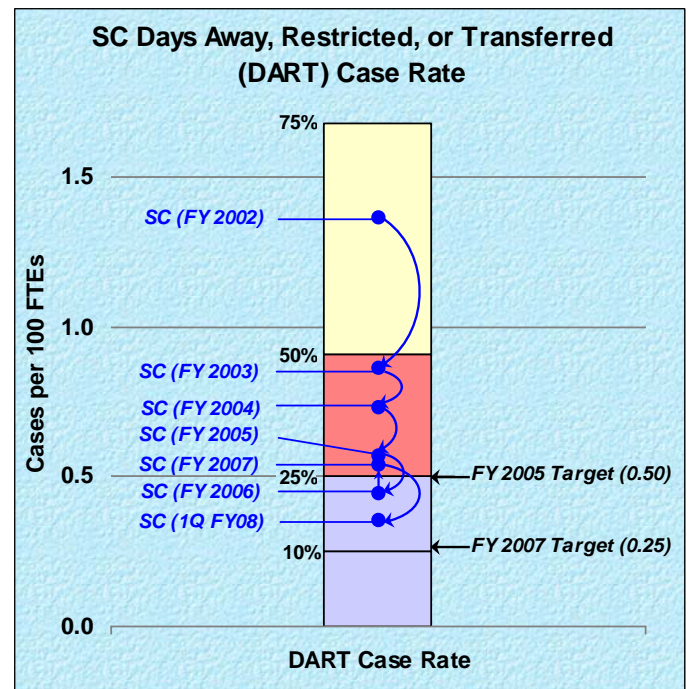
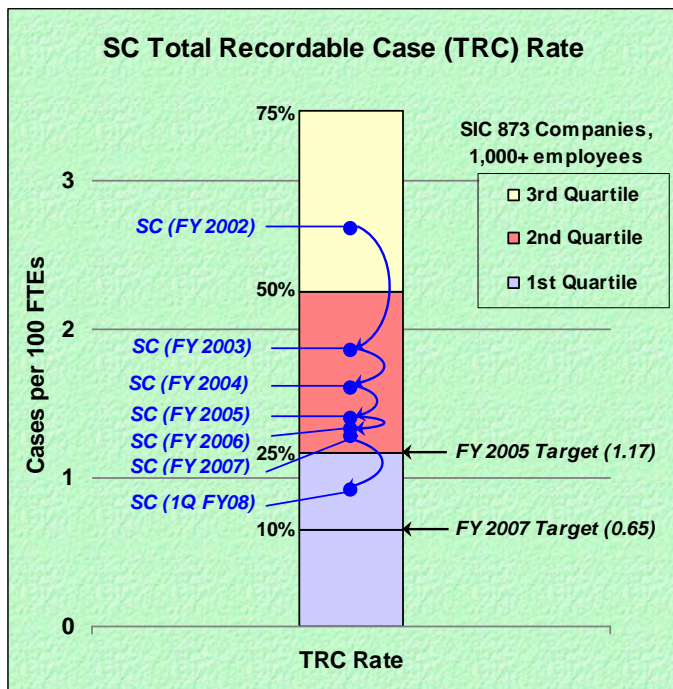
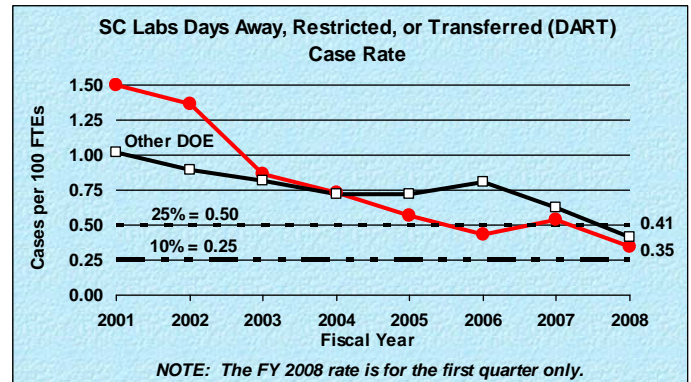
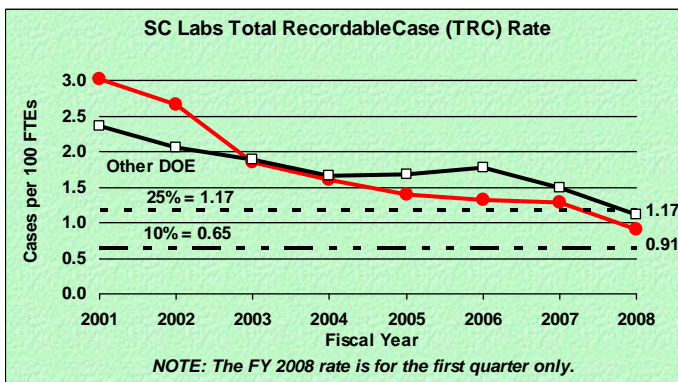
Office of Science Injury Rate Reduction Performance through December 2007

Total Recordable Case (TRC) Rate

- The SC complex had 47 cases through 1Q08.
- The SC TRC rate for 1Q08 (Oct.-Dec. 2007) was 0.91, a 29 percent decrease from the FY07 rate of 1.28.
- From FY02 to FY07, TRC cases decreased from 590 to 278, a 53 percent drop that reduced TRC injuries by 312.

Days Away, Restricted, or Transferred (DART) Case Rate

- The SC complex had 18 cases through 1Q08.
- The SC DART rate for 1Q08 (Oct.-Dec. 2007) was 0.35, a 35 percent decrease from the FY07 rate of 0.54.
- From FY02 to FY07, DART cases decreased from 302 to 118, a 61 percent drop that reduced DART injuries by 184.



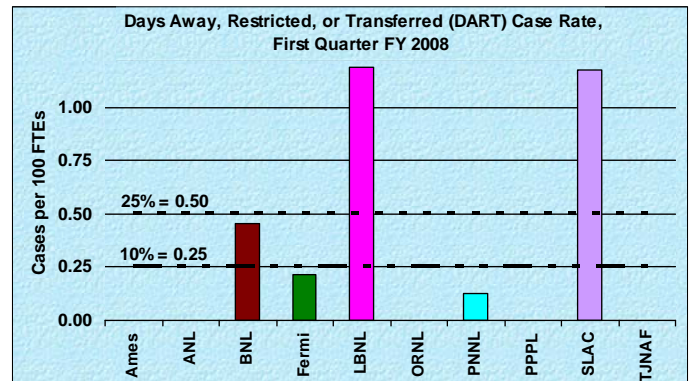
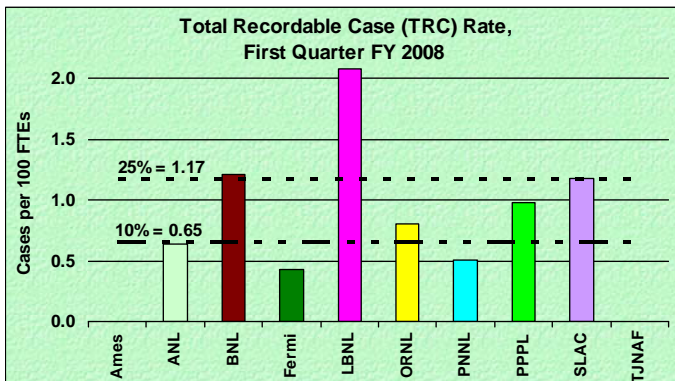
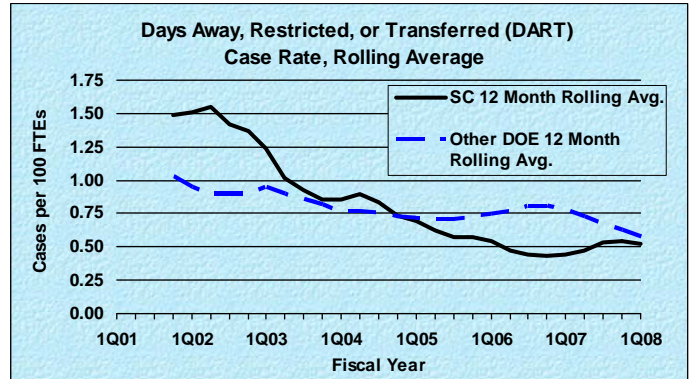
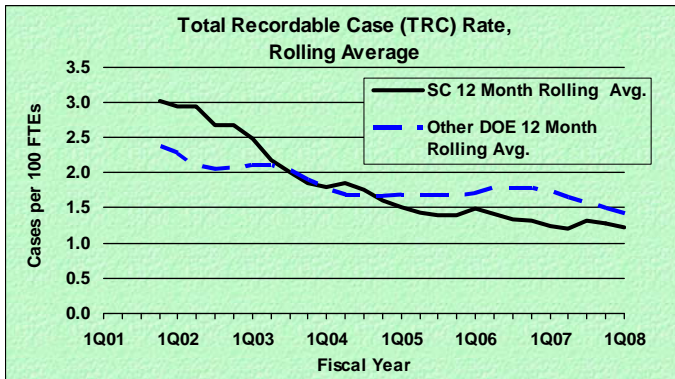

- The 12-month DART rolling average is beginning to level off.



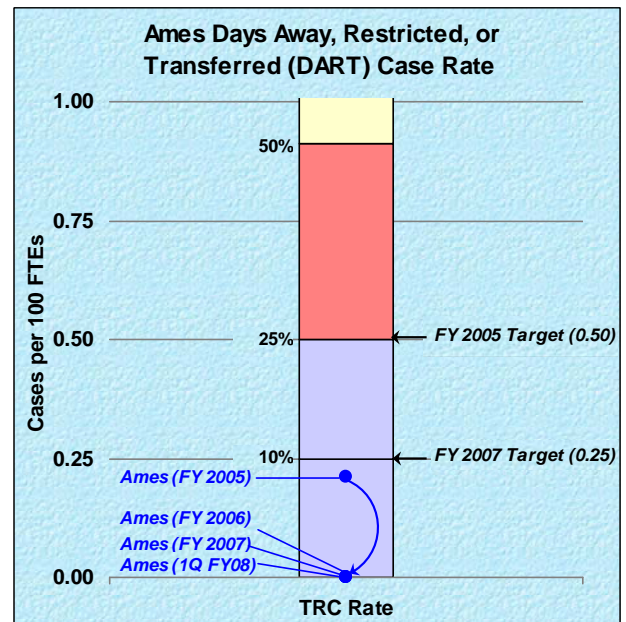
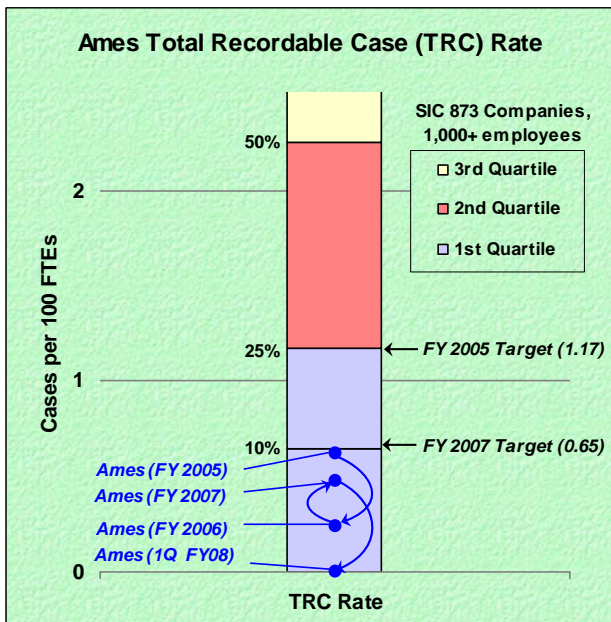
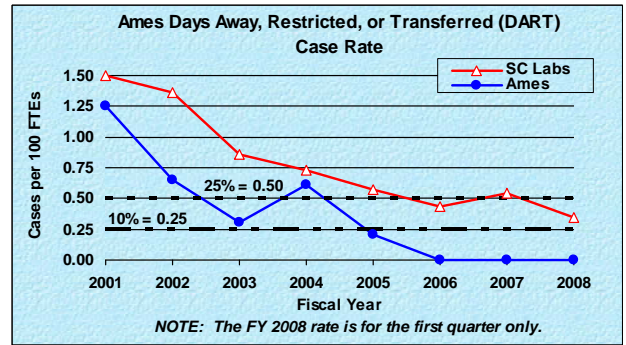
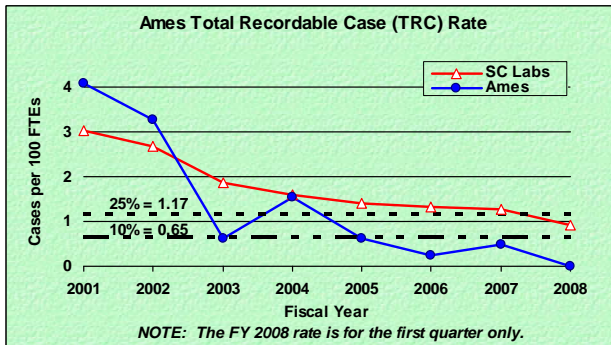
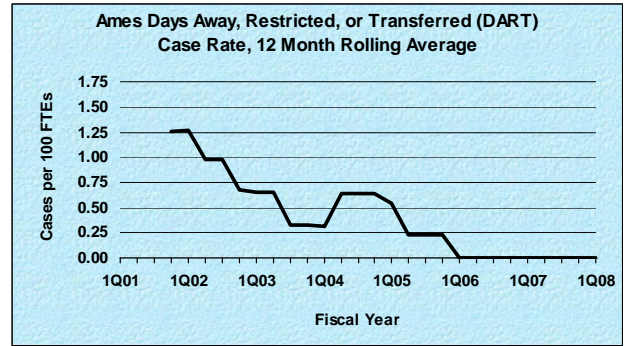
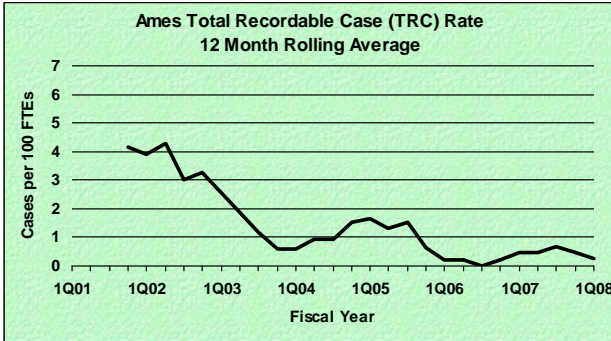

- The DART FY08 target rate of 0.25 is the equivalent of one DART case for Ames.



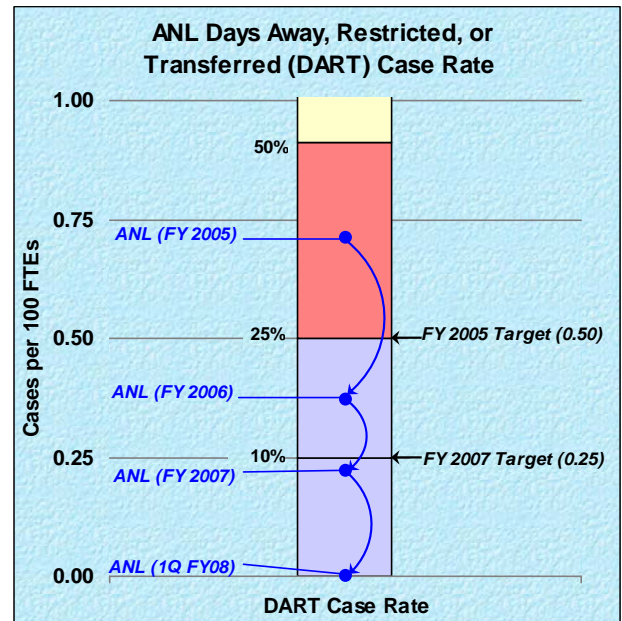
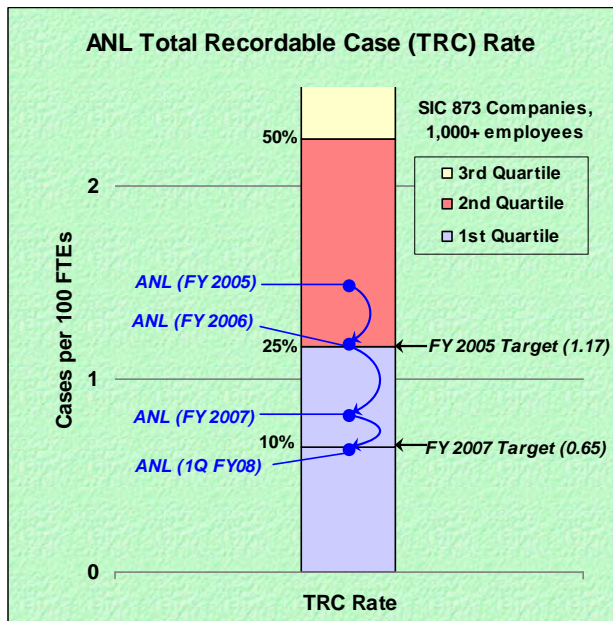
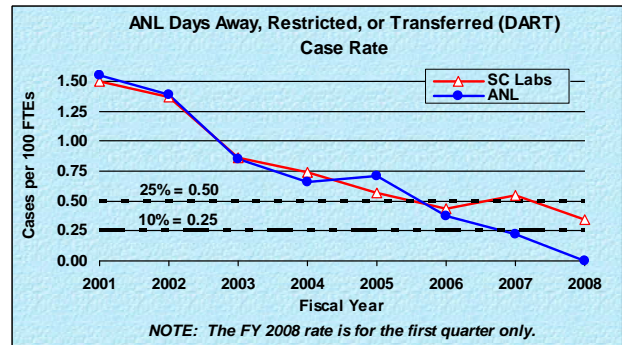
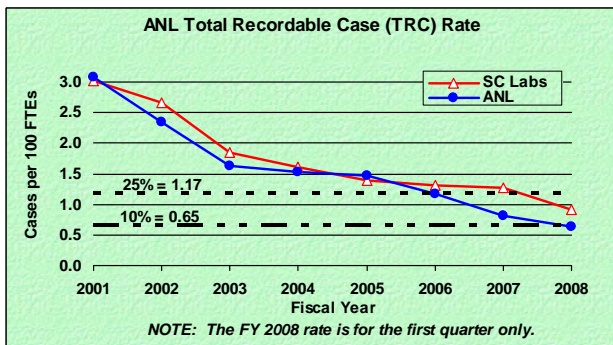
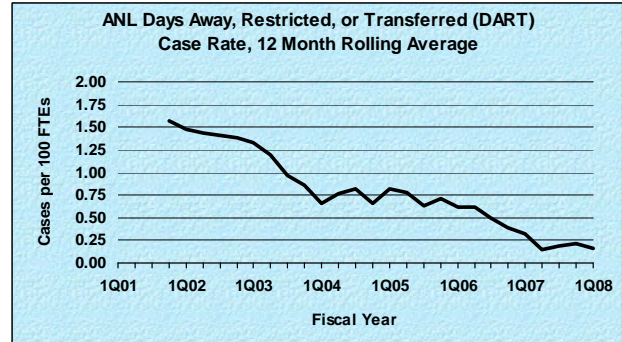
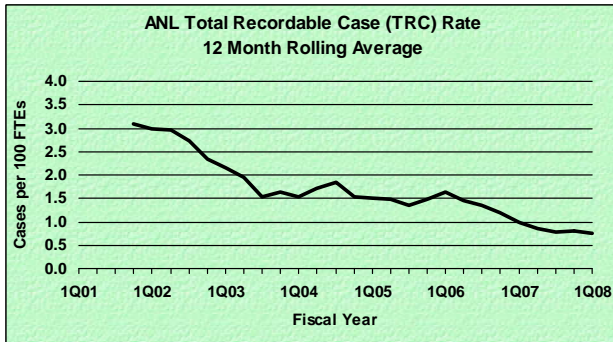
