SUBJECT: ANNUAL ASSESSMENT - COMANCHE PEAK STEAM ELECTRIC STATION

(REPORT 50-445, 446/02-01)

Dear Mr. Terry:

On February 13, 2002, the NRC staff completed its end-of-cycle plant performance assessment of Comanche Peak Steam Electric Station. The end-of-cycle review for Comanche Peak Steam Electric Station involved the participation of all technical divisions in evaluating performance indicators for the most recent quarter and inspection results for the period from April 1 through December 31, 2001. The purpose of this letter is to inform you of our assessment of your safety performance during this period and our plans for future inspections at your facility. This will provide you an opportunity to prepare for these inspections and to inform us of any planned inspections which may conflict with your plant activities.

As discussed in our previous annual assessment letter, dated May 29, 2001, this inspection and assessment cycle consisted of three quarters (i.e., the second, third, and fourth quarters of Calendar Year 2001) instead of the usual four quarters. This change was implemented in order to align the inspection and assessment cycle with the calender year beginning on January 1, 2002.

Overall, Comanche Peak Steam Electric Station operated in a manner that preserved public health and safety, and fully met all cornerstone objectives. Plant performance for the most recent quarter was within the Regulatory Response Column of the NRC's Action Matrix, based on one finding of low to moderate safety significance (White) in the Public Radiation Safety cornerstone.

Between January 24, 2000, and May 24, 2001, you identified 11 examples in which radioactive material was inadvertently released from the radiologically controlled area because of improperly conducted surveys. The significance of these events was determined to be of low-to-moderate risk based on the number of events (>5), and the public exposure associated with each event was less than 5 millirem. None of the material was released from the owner-controlled area; however, the individual examples revealed a potentially unmonitored pathway

for radioactive material to be released from the facility. A Notice of Violation associated with this issue was issued on February 21, 2002. In response to the low-to-moderate risk significant finding, NRC will conduct a Supplemental Inspection in accordance with NRC Manual Chapter 95001, "Inspection For One or Two White Inputs in a Strategic Performance Area," in addition to the baseline inspection program. This inspection has been scheduled for April 23-25, 2002. Also, both units will be inspected in accordance with Temporary Instruction 2515/145, "Circumferential Cracking of Reactor Pressure Vessel Head Penetration Nozzles (NRC Bulletin 2001-01)."

Immediately following the terrorist attacks on the World Trade Center and the Pentagon, the NRC issued safeguards advisories recommending that nuclear power plant licensees go to the highest level of security, and all promptly did so. With continued uncertainty about the possibility of additional terrorist activities, the Nation's nuclear power plants, including Comanche Peak Steam Electric Station, remain at a high level of security. On February 25, 2002, the NRC issued an Order to all nuclear power plant licensees, requiring them to take certain additional interim compensatory measures to address the generalized high-level threat environment. These additional compensatory requirements will provide the NRC with reasonable assurance that public health and safety and the common defense and security continue to be adequately protected in the current generalized high-level threat environment. These requirements will remain in effect pending notification from the Commission that a significant change in the threat environment occurs or until the Commission determines that other changes are needed following a more comprehensive re-evaluation of current safeguards and security programs. To date we have monitored TXU Generation Company LP's actions in response to the terrorist attacks through a series of audits. With the issuance of the Order, we will evaluate TXU Generation Company LP's compliance with these interim requirements.

The enclosed inspection plan details the inspections scheduled through March 31, 2003. The inspection plan is provided to minimize the resource impact on your staff and to allow for scheduling conflicts and personnel availability to be resolved in advance of inspector arrival onsite. Routine resident inspections are not listed due to their ongoing and continuous nature. The last 6 months of the inspection plan are tentative and may be revised at the Midcycle Review meeting.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be made available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records (PARS) component of NRC's document system (ADAMS). ADAMS is accessible from the NRC Web site at http://www.nrc.gov/reading-rm/adams.html (the Public Electronic Reading Room).
