Charge to Committee

- **Identify and Analyze the Most Effective Ways to Assess the Results of Research Consulting with Federal Agencies, Oversight Entities, Researchers, etc.**
- **Help the Federal Government Determine How Agencies can Better Incorporate Research Activities into their GPRA Plans**

- **Industry**
- **Strategic & Performance Plans**

Two Viewpoints in Workshops

- **Possible to measure research, including basic research, annually & provide quantitative outcomes of both basic & applied research**
- **Given long-range nature of basic research, no sensible way to respond to GPRA**

COSEPUP Position

- **Useful outcomes of basic research cannot be measured directly on an annual basis because inherently too unpredictable**
- **However, meaningful measures of performance of basic research are possible--quality, relevance, and leadership are good predictors of eventual usefulness and can be reported regularly**

Expert Review

- **Quality-- Peer Review of Programs by Experts in Field**
- **Relevance-- Relevance of Research to Agency Mission by Potential Users & Experts in Related Fields**
- **Leadership--International Benchmarking by International and National Experts**

Human Resources

- **Include goal of maintaining adequate human resources in fields critical to their missions in strategic & performance plans**
- **Make Human Resources part of Program Evaluation**

Coordination

- **Establish formal process to identify and coordinate areas of research supported by multiple agencies**
- **Identify lead agency for each field that would be responsible for assuring coordination occurs**

Science and Engineering Community

- **Should play an important role in GPRA implementation**
- **Become familiar with Agency Strategic & Performance Plans**

Conclusion

- **GPRA provides an opportunity to ensure effective use of nation's resources**
- **Articulates to policymakers and public the rationale for and results of research**
