PAC Chair Report → CDR Nita Sood (nsood@hrsa.gov)

- The PharmPAC expresses condolences to CAPT Kimberly Zietlow on the passing of her husband.
- As of November 1 the PharmPAC will transition to its new leadership for the 2007-2008 operational year. Both LCDR Violette Ganoe and CDR Beth Fritsch will undoubtedly serve the PharmPAC with distinction as they have this past year as Vice-Chair and Recruitment Section co-Lead respectively. LCDR Sohail Mosaddegh will serve as Executive Secretary. There are three new pharmacy liaisons to JOAG- LCDR Kristina Joyce, LCDR Kiem Ngo and LCDR Lori Hall. LCDR Joyce will be doing the monthly report for the PharmPAC.

CDR Sood began by presenting the fourth quarter and final report to the PAC for the operational year 2006-2007. The highlights of the great work done by your PharmPAC as follows:

Administration Section:

- The Administration section completed the process of PharmPAC membership nominations. There are 5 new voting members who will begin their 3 year term starting 1 November. CAPT Lia Prela from CMS, CDRs Christine Yu and Josephine Lyght from HRSA, CDR Scott Giberson and LCDR Brent Hobbs from IHS. Congratulations to all the new incoming members!

Career Development:

- Another successful immunization class was held on September 14th in the DC area - 30 additional pharmacists were trained in the APhA immunization course. Thanks to CAPT Bresette, CDRs Pincock and Olin for teaching the course and thanks to LCDR Keith Olin for coordinating the efforts. CDR Shiber trained 9 BOP pharmacists at the BOP training in Colorado.
- The non-APhA position paper is almost---It will be ready to go to OFRD by end of this month. The workgroup has identified non-APhA courses offered in the country that are equivalent to APhA and the PharmPAC is requesting OFRD to recognize them for deployment purposes.
- Once again this year- PHS pharmacists are providing flu vaccines at the FOH sites- Parklawn, and Whiteoak, and Outreach at VA and EPA locations.
- The PharmPAC has made great head way in attempting to get the APhA self-study modules on the OFRD website. Final touches are being made with OFRD and RADM Rutstein. The PharmPAC hopes to have that accomplished by the end of this month.
- Readiness numbers- CDR Sood commended each and every pharmacy officer in helping the pharmacy category achieve 84.1% readiness status as of September 23. The 84.1% is a very big deal for a large category. In fact, it's the highest percentage among the larger categories.
- Pharmacy Mentoring Program that was revitalized in May 2006 with ever growing mentor/mentee match-ups. Due to concerns about mentors signing up to be mentors for CV purposes and not giving the attention the mentees deserve. One possible solution was to hold a mentor training. The first computer based training session was held on Aug 16th. This training was recorded and is posted on the PharmPAC website. All new mentors will be expected to view this prior to getting assignments as mentors. CAPT Golson will be providing a full reporting at the November meeting.
- Information that is important to all officers for promotion, assimilations has been updated and posted on the PharmPAC website.
- The newly formed publishing workgroup is on its way. An article is almost complete that showcases the great work that PHS pharmacists are doing out there. Also, gets the word out about PHS as a career path.
- The new clinical subgroup has been formed and the PharmPAC will be hearing more about that in the upcoming months.
- CDC's IETA program was presented. Fellow pharmacists CDR Diwa and LCDR Thomas both graduates of the program gave the great presentation at the September meeting.

Communication Section:

- PLANT – in is place to have new profiles posted on the website and disseminated via pharmacist and student listserv. PLANT Profiles for Dr. Ilisa Bernstein and CAPT Justina Molzon were completed.
- The PHPW had identified some public health focus areas; On school outreach activities to prevent injuries/accidents in children and CAPT Hoppes presentation on the Youth Corps.

CDR Sood also recognized the officers providing the Agency Reports – these reports have been very informative. Other officers should consider taking over to present Agency Reports.

CDR Sood made some personal comments-

CDR Sood was thankful to have had the opportunity to serve as the PharmPAC chair and to have worked with members of the PAC. She indicated, she ends her term with hopes that she had served the PharmPAC well. She is proud of the great accomplishments of the PharmPAC and acknowledged this would not have been possible without the support of the CPO RADM Pittman, the dedication, commitment and hard work by the PAC members, section leads, and subcommittee members. She stated that the PharmPAC members were instrumental in moving the motivated agenda forward. One frustration was: it takes an inordinate amount of time to recognize officers for their work to the PAC and the Corps. She hoped the new PHS awards program will recognize deserving officers for their accomplishments and achievements in a timely manner.

During the 2006-2007 operational year, the PharmPAC did considerable work around the Transformation Process and there is considerable work still to be done. CDR Sood hoped that the PHS pharmacy officers, continue to take an active role in Transformation and be part of a team to shape the Commissioned Corps.
