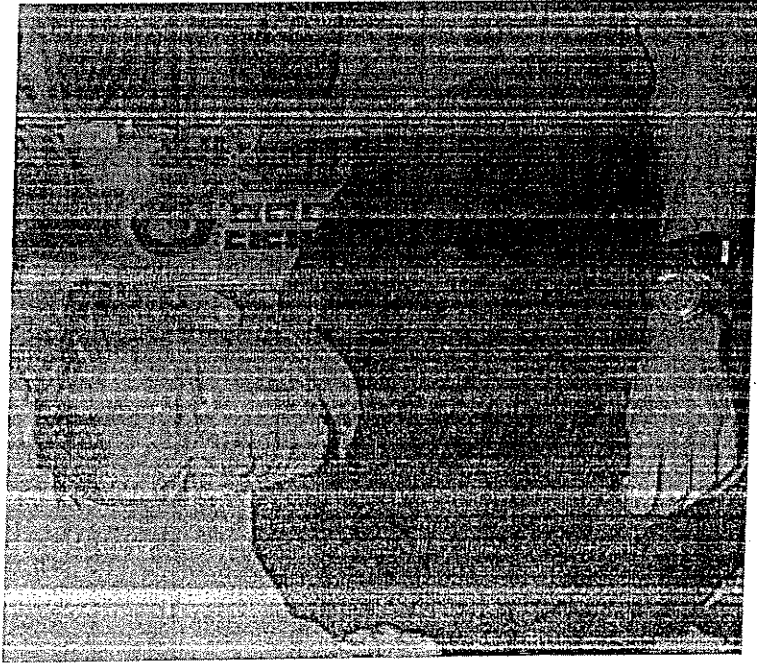

Hi Bill,

I'm pleased to tell you that my company is all in and would be honored to host the entire STS-116 crew in Alaska (that's 7 including Thomas Reiter), or however many would like to participate. As we discussed, we'll shoot for timing around the Iditarod, though we can be somewhat flexible on either side. The ceremonial start in Anchorage is on Saturday, March 3, with the restart in Wasilla the next day. Incidentally, the Tour of Anchorage xc ski race also takes places on Sunday, March 4. Spring break for most Alaska schools is the week of March 19 so we need to be done by then, or delay until after. I will send a follow up to my original request to the NASA Appearances office with a more definite outline of our plans regarding timing and the crew. I'm pretty comfortable with the list of potential appearances, with Anchorage and Kenai as the two priorities. If more time is available, we can add more appearances in another region (for group or you alone). Will the first/second weeks of March work in your crew appearances schedule? Are you in a position to name specific dates?

I also need to ask you about Monday, February 19 - The Challenger Learning Center is having a special event that day in Anchorage with the Starlab, to continuing enhancing awareness about their programs. I was asked about sponsoring your appearance at this; I gathered from our conversation that you and crew would probably be in Europe at that time, however I said I would ask if you were available for a solo appearance. Are you?

Back to March - I've been thinking about what we could do relative to the Iditarod that would involve the crew in an interesting way - either officially or unofficially. I don't want the race-related activities to detract from a competing crew appearances nor do I want to steal the thunder from the race, but I would like your comrades to have fun by experiencing this famous race and an Alaska winter event. As I was standing by a raging bonfire on New Year's watching 30 minutes of fireworks being lit off in our host's yard near Willow, I thought that something like that could be a fun thing for your group (it was slightly reminiscent of the bonfire in Valdez at the summer solstice during the theater conference, when some of us were inducted into the JW family). The fireworks were competing with the moonlight, there was lots of snow everywhere and the temperature was about 10 below, all this with copious amounts of food and beverage - it was the quintessential Alaska winter experience.

I was thinking out loud about it at dinner last night with one of our guests, Brian, who works with my husband at Baker Oil Tools (part of the worldwide BakerHughes family of companies headquartered in Houston). Brian said his company would love to host an Iditarod party for you guys that would involve riding snowmachines to the river to see the racers as they pass by after the official restart in Wasilla.

We'd ride to a lodge the night before, have dinner, bonfire and fireworks, and then watch the race the next day. Participants in the group would be your crew, some of the Baker guys and spouses, a few of their VIP clients, your brother and parents. The Baker boys are a nice bunch; they like to work hard, play hard, and they all love to hunt and fish. I don't think I would consider this to be an "official" event but NASA might think differently so I'm not sure how to include this any future correspondence with them; it's rendered moot if you're not interested. Let me know if this appeals to you, or if you think your crew would like to do it, or would prefer another adventure.

The agenda would look something like:

Thursday/Friday, March 1/2 - Arrive Alaska  
Saturday, March 3, a.m. - Watch ceremonial race start, downtown Anchorage  
Saturday, March 3, p.m. - Drive to Big Lake area, snowmachines to lodge  
Sunday, March 4, a.m. - Ride to race observation location  
Sunday, March 4, p.m. - Return to Anchorage  
Monday/Tuesday, March 5/6 - Anchorage appearances (various audiences - students, general public, etc)  
Wednesday/Thursday, March 7/8 - Kenai Peninsula appearances (ditto)  
Friday - program over; depart Alaska

I don't know if we could pull off everything as described, but that's the vision and I think we could get pretty close to implementing it.

Moving along - if this Iditarod plan isn't something you want to do or the timing doesn't work out, you could use the weekend to check out Mt. Alyeska; I think there is a dogsled ride vendor in the area, among other things. Baker would probably pick up the tab for some entertaining in Girdwood there instead. Most of the PR's you and I have done together have had pretty heavy work obligations in a short amount of time so I hope you'll be able to take advantage of this offer to some extent, but please don't feel any pressure to do so.

Other stuff - I think you can squeeze in some xc skiing time on the trails around Anchorage during the week; if you can provide me with shoe sizes of crew interested in trying it, I will round up equipment. I'd also like to offer a tour of Kuparuk Oil field facilities to the crew, if they're interested. I know that employees up there (lots of engineers) would be very interested to see your presentation, but I wouldn't make it a requirement to receive the tour.

For any of the winter activities, we have arctic gear available for people to check out. From parkas to down bibs, pac boots, balaclavas, etc. I'd arrange for this stuff ahead of time, so would need sizes. You folks have been to Antarctica so maybe you already have this stuff, but if you didn't want to pack it up here....

Lots of things to think about. I expect you have your own ideas about how you'd like to entertain your crewmates. I'd just like to show some Alaskan hospitality to your friends and have them leave here with great memories of their time spent in Alaska, so please let me know whatever I can do to help you achieve this.

Telecon with Luke Drury, James Webb, Dave Heintschel, Liz Phillips, Will Siggins, Sheri Locke - 10:10am:

- At 9:58am Lisa Nowak's ID (lnowak) was removed from the permissions from her home directory (jsc-fcod-ca1/lnowak). After discussing this with Luke Drury, a decision was made to deny access to lnowak and William Oefelein's ID's (woefelei) at the server level to both jsc-fcod-ca1 and jsc-fcod-ca5 rather than to their home directories. Server access was denied for CA1 at ~10:10am and CA5 at ~ 10:25am for both users.
- Request from Luke Drury to preserve and maintain custody of all backup tapes for jsc-fcod-ca1 and jsc-fcod-ca5. The backups should go back for 1 year and include daily's, weekly's and monthly's. This will consist of ~235 tapes. We will reassess this over the next few days to make sure we need to retain all of this data. If a decision is made that all of this data needs to be retained for an indefinite amount of time, then we will have to procure replacement tapes (~\$14K). We are going to make a rush buy of 20 tapes today to ensure that we can keep the backup schedule intact for the next 3 weeks.
- Luke requested that we provide a DVD copy of the home directory's for both Lisa Nowak and William Oefelein. These are to be completed and delivered to Luke today.
- Decision was made to run a full backup starting tonight of both jsc-fcod-ca1 and jsc-fcod-ca5.
- Eddie Escamilla brought up the question of whether NALCOMIS data needed to be preserved. Luke said that we need to retain a copy of the access logs since once a user enters data into NALCOMIS they cannot go back in and change it. So the access logs along with the standard backup tapes will provide any evidence that may be needed.

Telecon with Matt Borck, Eddie Escamilla, James Webb, Dave Heintschel, Liz Phillips, Will Siggins and Sheri Locke - 10:23am

- We will pull all tapes from the backup tape unit and also pull all tapes with any backup data through the last 12 months and place them in the vault for safe keeping. These tapes need to be labeled in a way to ensure that they will not be reused.
- Sheri will procure 20 LTO2 tapes for use over the next 3 weeks until we determine whether all backup tapes (~235) need to be retained.

Telecon with John Corbett, James Webb, Dave Heintschel, Liz Phillips, Will Siggins and Sheri Locke - 10:45am

- We brought up the issue of the Astronaut Quarantine Facility here at JSC and the Astronaut Crew Quarters at KSC. There are 4 communal machines here at JSC and 8 communal machines at KSC which both Lisa Nowak and William Oefelein had access to during their recent Shuttle missions. John Corbett asked that we retain the data from these machines.

An astronaut drives 1000 miles wearing diapers to try and "kill" with a BB Gun? a woman whom she suspected of stealing the affection due her from another astronaut.

"Wow....talk about stealing defeat from victory, this is a great one.

And the poor PR folks at NASA are sitting around minding their own business when all of a sudden the phone rings...

Well, what I just heard on NPR at 5:30 Memphis time, was a truly great response in the midst of a crisis by NASA. Here's what the PR person said:

"Lisa Nowak performed very well on her shuttle mission. We are all family here at NASA and we support our families. we just don't understand at this time anymore than anyone else does what has happened."

Truly a supportive but careful statement. We are FAMILY. We support our FAMILIES...not necessarily Lisa but our FAMILIES. and then "we don't understand what has happened." Puts a personal face on NASA.

Hindsight being 20/20 just think how Duke would have looked if regarding the lacrosse team -- initially they had said: "We support all our students and we are all family. We don't know what happened and we are working to understand how all of this happened and we will be working toward that goal over the next few days."

Of course NASA also said early on that they had no policy on fraternizing among astronauts...well, of course NASA may not but this woman and the guy involved are officers in the NAVY which does have a policy on that ...like don't do it."

but, hats off to NASA...no doubt they will have to make a "harder" statement in the future...but if you have a crisis and are looking for words to sound good and allow wafel room...NASA made it look easy today.

And...

1) In addition to compassion through the 'we are family' statement, it's revealing what NASA decided not to do - defend the accused, nor offend the accused. Instead, it said we don't understand, a neutral posture given lack of knowledge.

NASA affirmed her work specifically as an astronaut, thus affirming its own sphere of responsibility while tacitly putting distance between it and her personal life without having to spell it out. The position it took was not on her personal life but professional life.

3) Even without the facts, NASA responded. Imagine if they had said 'no comment.' no
