15	IRAQ, THE ESTABLISHMENT OF BENCHMARKS TO MEAS-
16	URE THAT PROGRESS, AND REPORTS TO CONGRESS.—
17	Congress makes the following findings:
18	(1) Over 145,000 American military personnel
19	are currently serving in Iraq, like thousands of oth-
20	ers since March 2003, with the bravery and profes-
21	sionalism consistent with the finest traditions of the
22	United States Armed Forces, and are deserving of
23	the strong support of all Americans.
24	(2) Many American service personnel have lost
25	their lives, and many more have been wounded in

1	Iraq; the American people will always honor their
2	sacrifice and honor their families.
3	(3) The United States Army and Marine Corps,
4	including their Reserve components and National
5	Guard organizations, together with components of
6	the other branches of the military, are performing
7	their missions while under enormous strain from
8	multiple, extended deployments to Iraq and Afghani-
9	stan. These deployments, and those that will follow,
10	will have a lasting impact on future recruiting, re-
11	tention, and readiness of our Nation's all volunteer
12	force.
13	(4) Iraq is experiencing a deteriorating problem
14	of sectarian and intrasectarian violence based upon
15	political distrust and cultural differences among fac-
16	tions of the Sunni and Shia populations.
17	(5) Iraqis must reach political and economic
18	settlements in order to achieve reconciliation, for
19	there is no military solution. The failure of the
20	Iraqis to reach such settlements to support a truly
21	unified government greatly contributes to the in-
22	creasing violence in Iraq.
23	(6) The responsibility for Iraq's internal secu-
24	rity and halting sectarian violence rests with the sov-

ereign Government of Iraq.

25

1	(7) In December 2006, the bipartisan Iraq
2	Study Group issued a valuable report, suggesting a
3	comprehensive strategy that includes new and en-
4	hanced diplomatic and political efforts in Iraq and
5	the region, and a change in the primary mission of
6	U.S. forces in Iraq, that will enable the United
7	States to begin to move its combat forces out of Iraq
8	responsibly.
9	(8) The President said on January 10, 2007,
10	that "I've made it clear to the Prime Minister and
11	Iraq's other leaders that America's commitment is
12	not open-ended" so as to dispel the contrary impres-
13	sion that exists.
14	(9) It is essential that the sovereign Govern-
15	ment of Iraq set out measurable and achievable
16	benchmarks and President Bush said, on January
17	10, 2007, that "America will change our approach
18	to help the Iraqi government as it works to meet
19	these benchmarks".
20	(10) As reported by Secretary of State Rice,
21	Iraq's Policy Committee on National Security agreed
22	upon a set of political, security, and economic bench-
23	marks and an associated timeline in September 2006
24	that were (A) reaffirmed by Iraq's Presidency Coun-

cil on October 6, 2006; (B) referenced by the Iraq

25

1	Study Group; and (C) posted on the President of
2	Iraq's Web site.
3	(11) On April 21, 2007, Secretary of Defense
4	Robert Gates stated that "our [American] commit-
5	ment to Iraq is long-term, but it is not a commit-
6	ment to have our young men and women patrolling
7	Iraq's streets open-endedly" and that "progress in
8	reconciliation will be an important element of our
9	evaluation".
10	(12) The President's January 10, 2007 address
11	had three components: political, military, and eco-
12	nomic. Given that significant time has passed since
13	his statement, and recognizing the overall situation
14	is ever changing, Congress must have timely reports
15	to evaluate and execute its constitutional oversight
16	responsibilities.
17	(b) Conditioning of Future United States
18	STRATEGY IN IRAQ ON THE IRAQI GOVERNMENT'S
19	RECORD OF PERFORMANCE ON ITS BENCHMARKS.—
20	(1) In general.—
21	(A) The United States strategy in Iraq,
22	hereafter, shall be conditioned on the Iraqi gov-
23	ernment meeting benchmarks, as told to mem-
24	bers of Congress by the President, the Sec-
25	retary of State, the Secretary of Defense, and

1	the Chairman of the Joint Chiefs of Staff, and
2	reflected in the Iraqi Government's commit-
3	ments to the United States, and to the inter-
4	national community, including:
5	(i) Forming a Constitutional Review
6	Committee and then completing the con-
7	stitutional review.
8	(ii) Enacting and implementing legis-
9	lation on de-Baathification.
10	(iii) Enacting and implementing legis-
11	lation to ensure the equitable distribution
12	of hydrocarbon resources of the people of
13	Iraq without regard to the sect or ethnicity
14	of recipients, and enacting and imple-
15	menting legislation to ensure that the en-
16	ergy resources of Iraq benefit Sunni Arabs,
