

Public Assistance

Aid to government entities and certain not-for-profit agencies. Over 1,400 Public Assistance grants have been prepared to date.

Note: Dollar amounts in parenthesis represent total amount currently approved for applicant or activity. Examples of grants include:

LOWER MANHATTAN TRANSPORTATION INFRASTRUCTURE (\$2.75B)

- \$2.75B to revamp transportation infrastructure (plus \$1.8B from USDOT for a total of \$4.55B)

DEBRIS REMOVAL (\$636M)

- \$437M for debris removal
 - \$97M for landfill operations and debris disposal
 - \$96M for costs associated with insurance coverage obtained for debris removal activities
- \$636M estimate is for NYC DDC and DSNY, and does not include FDNY, NYPD or USACE.*

EMERGENCY TRANSPORTATION (\$80M)

- \$43M for emergency ferry service
- \$17.5M for additional emergency train service
- \$9.1M for road repairs
- \$5.2M for temporary bridge and walkway
- \$3.8M for emergency bus service
- \$1M for emergency traffic operations

CLEANING AND AIR MONITORING (\$98M)

- \$85M for DEP/EPA indoor residential cleaning
 - \$10.1M for DEP exterior building cleaning
- See NYC Department of Education for additional cleaning and air monitoring grants*

FIRE DEPARTMENT OF NEW YORK (\$197M)

- \$149.4M for overtime, backfill, death benefits, and funeral costs
- \$43.8M for destroyed vehicles, radios, 10/10 Fire House, and equipment; and equipment usage
- \$3.7M for cleaning and decontamination

NEW YORK POLICE DEPARTMENT (\$346M)

- \$319.6M in overtime at Ground Zero, Fresh Kills landfill, and incident command centers
- \$17M for vehicle usage
- \$5.4M for destroyed vehicles
- \$3.5M for emergency equipment usage

NYC DEPARTMENT OF EDUCATION (\$14M)

- \$77.6M to replace lost instruction time
- \$4.4M for asbestos abatement and school repair/cleanup
- \$2.9M for air quality testing in schools
- \$1.5M for HVAC cleaning at Stuyvesant HS
- \$3.1M for school relocation and transportation
- \$734,000 for textbooks and calculators

PRIVATE NOT-FOR-PROFIT (\$10.5M)

- \$5.9M for New York University for air monitoring, environmental cleaning and emergency educational supplies/services
- \$4.1M for Pace University air quality testing, emergency supplies, equipment and repairs

PORT AUTHORITY OF NEW YORK AND NEW JERSEY (\$182.7M)

- \$73.2M for office relocation and build-out
- \$57.5M to repair PATH tunnels
- \$28.8M for overtime
- \$11.8M for operating costs for emergency commuter ferry service
- \$7.2M to replace destroyed rail cars
- \$2.6M to construct ferry landing at Pier A
- \$1.3M to replace destroyed vehicles

OTHER DIRECT AID TO NY CITY (\$352M)

- \$56M for DNA testing, forensic analysis and equipment for victim identification
- \$17.5M for temporary relocation of CUNY's Fiterman Hall
- \$12.9M to Citywide Admin. Services for emergency supplies, equipment and services
- \$8M to NYC for Cancelled Elections
- \$7.5M for NYC Family Center

DIRECT AID TO NY STATE (\$125.3M)

- \$45M to NY State Police for Ground Zero security operations
- \$20M to NY State Military and Naval Affairs for activation of National Guard
