3.0 **DEFINITIONS**

<u>HEDS</u> - Human Exploration and Development of Space, one of NASA's five Strategic Enterprises. It is comprised of the Office of Space Flight.

<u>THREADS</u> - Technology for Human/Robotic Exploration and Development of Space, a family of strategic research and technology road maps defining the technology areas of future importance to HEDS.

<u>ESMB</u> - Exploration Senior Management Board. Senior representatives of the several Centers and Enterprises involved in the success of HEDS technology investments.







6.0 HUMAN EXPLORATION AND DEVELOPMENT OF SPACE TECHNOLOGY PLANNING PROCESS STEPS

The planning process and budgeting for human exploration and development of space technologies is accomplished by the HEDS enterprise at NASA Headquarters. This process includes interaction with the NASA centers to develop the plans, priorities and budgets. The following table includes the reference to the process flowchart included in Section 5.0 of this document, the designated actionee responsible for each process action, and an explanation of the action required to progress the process to its completion.

<u>Actionee</u>	Flowchart Reference	Action
Code MP	1	Prepare for the conduct of Human Exploration and Development of Space (HEDS) supporting technology-systems analysis studies. This request is forwarded to various NASA centers, specifying the planning assumptions to be used in conducting studies and identifying requirements.
Code MP	2	Guide and participate, with the NASA Centers, in HEDS systems analysis and mission studies and discussions to formulate mission concepts, advanced systems concepts and technology needs.
Code MP	3	Formulate revised edition of the THREADS Strategic Research and Technology Road Maps, based on results for technology- systems analysis and mission studies, including updates to the THREADS work breakdown structure, strategic schedules of milestones and detailed technology planning content.
Code MP	4	If revisions are not accepted, return to Activity Step 2.
Code MP	5	Develop, using inputs from various organizations, THREADS investment planning documents and funding requirements, including a "gap analysis" based on related R&T planning by various NASA and non-NASA organizations, and prioritization of elements. Organizations from whom information is expected to be obtained include Code B and other NASA Enterprises. Results to include updates of technology options for future mission studies and planning.
Code MP	6	Revised THREADS strategic research and technology road maps, planning documents and funding requirements with the Exploration Senior Management Board.

Code MP	11	Present updated THREADS road maps and investment advocacy briefing materials to Agency Senior Management (e.g., CIC, Code B). Review and compare current and planned Agency R&T investments with needs (as documented in THREADS road maps)
Code MP	12	If revisions are necessary, return to Activity Step 8.
Code MP	13	Submit updated THREADS road maps and investment advocacy briefing materials to the Office of Management and Budget (OMB). Review and compare current and planned Agency R&T investments with needs (as documented in THREADS road maps)
Code MP	14	If revisions are necessary, return to Activity Step 8.
Code MP	15	Final Update THREADS of strategic research and technology road maps for Fiscal Year
Code MP	16	In line with the approved updates to the THREADS strategic research and technology road maps, implement or refocus needed/prioritized research and technology investments—in partnership with the several NASA field centers, industry and universities.
Code MP	17	Submit THREADS research and technology investment results from previous year(s) for review by and discussion with the HEDS/OSF Associate Administrator.
