Note: The first row for each type of committee contains the number of committees with disbursements within the column range.

The second row for each type is the percentage of all committees of that type who had disbursements in the column range.

The third row contains the total dollars spent by committees of that type in a particular range.

The fourth row represents the percentage of all dollars spent by that type of committee made by committees in the column range.

For example, 259 corporate sponsored committees (14.75% of all corporate committees) made disbursements of between \$50,001 and \$100,000 during 2003-2004.

Those 259 committees spent \$18.961 million dollars, which was 8.56% of all corporate sponsored PAC disbursements.
