Federal Election Commission Equal Employment Opportunity (EEO) Information

On May 15, 2002, President George W. Bush signed the Notification and Federal Employee Antidiscrimination and Retaliation Act (No Fear Act) which increases federal agency accountability for acts of discrimination or reprisal against employees.

One of the requirements of the No Fear Act is that federal agencies post on their public web sites certain summary statistical data relating to equal employment opportunity complaints filed against the respective agencies.

The Federal Election Commission's public web site contains statistical information in accordance with the No Fear Act. The data is updated on a quarterly basis.
