guidelines for health care
facilities in the event of an

avian influenza outbreak have been issued by The World Health Organization (WHO). The purpose of this document is to provide infection control guidance for health care workers (HCWs)* in health care facilities evaluating or providing care for patients with suspected or confirmed avian influenza (AI) infection, including AI A (H5N1).

◆ Senate Confirms Edwin G. Foulke Jr. to Lead

OSHA: On March 15, Secretary of Labor Elaine Chao announced that the United States Senate has confirmed Edwin G. Foulke Jr. of South Carolina as assistant secretary of labor for occupational safety and health. President George W. Bush nominated Foulke Sept.15, 2005, to head OSHA. There has been no head of OSHA since John Henshaw left in early 2005.
