

Stennis Fitness Program Coordinator Uses AED to Save a Life! Dr. Scott Burks,



at Stennis Space Center (SSC), received a Frontline Award July 31, from SSC Deputy Director Gene Goldman for his quick thinking and life-saving efforts in providing critical emergency aid to an SSC employee through the use of AED and CPR on July 5. The award is given by the office of SSC's Center Director to employees who demonstrate selfless commitment to protecting and preserving human life while maintaining personal safety and the safety of others. Scott relates how the employee was talking to him and then went down. He stated "everything was right there, the AED was 5-10' away." Scott then instructed a coworker to call 9-1-1. After determining no breath or pulse, Scott used the AED which indicated defibrillation was needed. The patient responded after defibrillation and a few rescue breaths by Scott. The SSC employee, who was transported to SSC's medical clinic and to a local hospital, is back to work and is using the wellness center again. AEDs have been a requirement in NASA fitness centers for many years.

- ◆ EHRS Update: It was recently announced that NASA EHRS Project will be pursuing a Commercial Off the Shelf (COTS) Occupational Health (OH) EHRS software application. This change in direction will allow us to find a solution that will ultimately be more cost effective for the Agency and avoid having to develop OH functionality available in commercial applications. The EHRS Project Team is reviewing the market research done several years ago on several OH EHRS products available commercially and updating the functional requirements.
