◆ EHRS Update: The EHRS Project Team continues to review available Commercial Off the Shelf (COTS) Occupational Health (OH) Electronic Health Record Systems (EHRS). Recently, the team has participated in two EHRS demonstrations and evaluated the software based on a predefined set of technical and functional requirements.

Spotlight on the Certified Occupational Health Nurse (COHN) Certification: The American Board for



Occupational Health Nurses (ABOHN) was established as an independent nursing

specialty certification board in 1972. ABOHN was formed to develop and conduct a program of certification for qualified occupational health nurses. ABOHN is the sole certifying body for occupational health nurses in the United States and awards four credentials: Certified Occupational Health Nurse (COHN), Certified Occupational Health Nurse - Specialist (COHN-S), Case Management (CM), and Safety Management (SM). Over 12,000 occupational health nurses have been certified by ABOHN. The Agency OH office is currently reviewing COHN preparation material and will be making a decision soon regarding their purchase.
