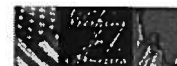

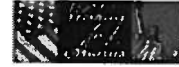

QUALIFICATIONS REQUIRED:



Applicants must meet the basic qualifications requirement outlined in the OPM Qualifications Standard Handbook.

Education: Degree or diploma from a professional nursing program approved by the legally designated State accrediting agency at the time the program was completed by the applicant.

Registration: Applicants must have active, current registration as a professional nurse in a State, District of Columbia, the

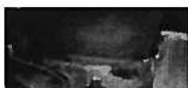
Commonwealth of Puerto Rico, or a territory of the United States.

Applicant who has graduated from an approved nursing educational program within the past 12 months may be appointed pending State registration as a professional nurse within 6 months of appointment. No person appointed pending registration may be retained beyond 6 months, or promoted, if registration has not been attained.

Since this position has a specific education requirement, you must submit a copy of your college transcript or acceptable alternative as indicated in Required Documents. If selected, you will be required to submit an original official transcript before being appointed.

In addition, applicant must possess at least one year of specialized experience equivalent to the next lower grade level in the Federal service.

Specialized experience is that which is directly related to the position and which has equipped the applicant with the particular knowledge, skills, and abilities (KSAs) to successfully perform the duties of the position, to include experience in the design and development of projects relating to the social and public health issues relating to genomics research.



* All applicants must meet the qualification requirements of this position by the closing date of the job announcement.

* All male citizens of the United States born after December 31, 1959, must be registered for the Selective Service to be eligible for Federal employment. For more information about registering with the Selective Service visit: www.sss.gov.

* Time in grade, if applicable, must be met within 30 calendar days of the closing date of the announcement.

HOW YOU WILL BE EVALUATED:

Your experience, education, training, self-development, and responses to the assessment and core questions will be evaluated and rated based on the requirements of the position. To receive full consideration for the position, you are highly encouraged to substantiate your responses to the assessment and questions when completing your application. Failure to substantiate your responses, exaggeration of your qualifications, or misrepresentation of your experience may result in a lower rating and consequently your chances of being considered for selection.
