- (b) Auction Sales Submission of the required bid desposit and a written bid is required to qualify for oral bidding. Oral bidding shall begin from the highest written bid. NOTES:

- 1. A new Special Provision has been added to the contract which enables the Contracting Officer to suspend the contract to facilitate protection of certain plant or animal species, and/or to modify or terminate the contract when necessary to comply with the Endangered Species Act, or; comply with a court order. This contract provision limits the liability of the Government to the actual costs incurred by the Purchaser which have not been amortized by timber removed from the contract area.
- 2. Seasonal restrictions and daily operating restrictions (DOR) on operations apply (see attached Seasonal Restriction Matrix).
- 3. Protection of marbled murrelet habitat located within the timber sale contract area is required. Protection measures include no cutting or removal of timber within the designated murrelet habitat area, an on-site pre-work conference to discuss protection measures and a seasonal restriction on logging operations located within the designated habitat area (all harvest areas except the NW portion of Unit 2) from April 1 to August 5, both days inclusive, of each calendar year. In addition, all operations in all harvest areas shall be scheduled such that daily work begins a minimum of two (2) hours after sunrise and concludes a minimum of two (2) hours before sunset from August 6 to September 15, both days inclusive, of each calendar year in order to prevent potential disturbance of nesting marbled murrelets.
- 4. This one hundred twenty-three (123) acre density management sale contains the following areas: approximately seventy-eight (78) acres of cable yarding, forty-five (45) acres of ground-based yarding, and five (5) acres of right-of-way cutting. - 5. Yarding of log lengths greater than forty (40) feet will not be permitted.
