This report is composed annually by the Finance, Systems, and Quality Group (FSQG) of the Health Care Financing Administration (HCFA). The Enrollment Report profiles Medicaid managed care programs on a plan-specific basis as of June 30, 2000. The information was collected from State Medicaid agencies and the Health Care Financing Administration (HCFA) Regional Offices. Data is presented for all States, the District of Columbia, Puerto Rico, and the Virgin Islands. Data is not presented for the following territories: Guam, Northern Mariana Islands, and American Samoa.

Medicaid Managed Care 2000 Enrollment Fact Sheet (Major Changes from 6/30/1999 - 6/30/2000)

Alabama - 1) Managed Care Enrollment was reported incorrectly for 1999. For 2000, the RO agreed that we should use the enrollees in the PHP as the managed care enrollment as it provides a more accurate count; 2) State Medicaid Enrollment increase is due to the number of children eligible for Medicaid; 3) State requested to combined all PCCMs for 2000 because it was not necessary to report each county PCCM separately; 4)Prime Health* no longer participates in the Medicaid program.

Arizona - 1) The State Medicaid Enrollment increase was due to a significant growth in the 1931 category, which includes families with children and also the 1931 Family and Children's group; 2) Doctors Health Plan* no longer participates in the Medicaid program.

California - State contracted with additional dental PHP plans. State requested to reclassify some of their MCOs reported in 1999 to Medical-only PHPs for 2000. The Medical-only PHP definition provides a more accurate description of plans that CA contracted for non-comprehensive medical services.

Colorado - The State Medicaid Enrollment increase was due to the inclusion of the retroactivity and as a result is significantly higher than reported on previous years which did not include retroactivity. For example a beneficiary was determined eligible on 1/15/2000 with an effective date of 6/1/2000 is included in the June 30, 2000 figure. This client would not have been included in the total reported last year. This year's method better reflects total eligibility because claims are frequently incurred during this period of retroactivity.

Delaware - Amerifirst * no longer participates in the Medicaid program.

District of Columbia - State misinterpreted the definitions for commercial vs Medicaid-only MCOs in 1999 and requested to reclassify all MCOs as Medicaid-only for 2000.

Florida - 1)The State Medicaid Enrollment increase was due to outreach and expansion of Medicaid eligibility for children and teens; 2) Alpha Health Plan* no longer participates in the Medicaid program.

Illinois - Accord Health Plan*, American Health Providers Inc.*, County Care Total Health Plan*, Illinios Healthcare Community Health Choice*, UIHMO*, and Your Health Network** no longer participate in the Medicaid program.

Idaho - The State Medicaid Enrollment increase was due to outreach efforts in the SCHIP program.

Indiana - Managed Health Services * Disability program was terminated.

I owa - Care Choice * no longer participates in the Medicaid program.

Kentucky - Kentucky Access program (mental health) was terminated.

Massachusetts - Harvard Pilgrim Health * no longer participates in the Medicaid program.

Mississippi - 1) The State Medicaid Enrollment increase was due to efforts to re-enroll eligibles who lost eligibility for Medicaid when TANF was implemented and SCHIP enrollment; 2) Capitated HMO program was terminated.

Missouri - 1) The State Medicaid Enrollment increase was due to outreach conducted for MC+ For Kids; 2) Prudential Health Plan* no longer participates in the Medicaid program.

Montana- The Managed Care Enrollment decrease was due to the termination of the Prepaid Mental Health Program.

New Hampshire - Turf Associated Health * no longer participates in the Medicaid program. Matthew Thornton Health has changed its name to Anthem Blue Cross/Blue Shield.

New York - Community Health Plan* and Empire Blue Cross/Blue Shield Healthnet1 no longer participate in the Medicaid program.

North Carolina - The Managed Care Enrollment decrease was due to the termination of Carolina Alternatives and HMO program.

Ohio - Mediplan * no longer participates in the Medicaid program.

Puerto Rico - United Healthcare * no longer participates in the Medicaid program.

Rhode Island - Harvard Pilgrim Health Care * no longer participates in the Medicaid program.

South Carolina - The State Medicaid Enrollment increase was due to SCHIP population.

Texas- The Managed Care enrollment increase was due to expansion of service areas and plans.

Vermont - Vermont Health Access HMO program was terminated.

Virginia - Optimum Choice * no longer participates in the Medicaid program.

Washington - The State Medicaid Enrollment increase was due to efforts to re-enroll eligibles who lost eligibility for Medicaid when TANF was implemented.

West Virginia - Optimum Choice * no longer participates in the Medicaid program.

Wisconsin - The State Medicaid Enrollment increase was due to SCHIP Medicaid and Medicaid Healthy Start population expansions.

2000 Medicaid Managed Care Enrollment Report Glossary as of June 30, 2000

Terms used in "Managed Care Entity" column

PCCM - Primary Care Case Management (PCCM) Provider is a provider (usually a physician, physician group practice, or an entity employing or having other arrangements with such physicians, but sometimes also including nurse practitioners, nurse midwives, or physician assistants) who contracts to locate, coordinate, and monitor covered primary care (and sometimes additional services). This category include PCCMs and those PHPs which act as PCCMs.

PHP - Prepaid Health Plan provides less than comprehensive services on an at risk basis or one that provides any benefit package on a non-risk basis. For example, medical-only PHP, Dental PHP, Transportation PHP, Mental Health PHP, Substance Abuse PHP, etc.

Commercial MCO - A Commercial MCO is a health maintenance organization, an eligible organization with a contract under §1876 or a Medicare-Choice organization, a provider sponsored organization or any other private or public organization which meets the requirements of §1902(w). These MCOs provides comprehensive services to commercial and/or Medicare enrollees, as well as Medicaid enrollees.

Medicaid MCO - A Medicaid MCO provides comprehensive services to Medicaid beneficiaries, but not commercial or Medicare enrollees.

HIO - Health Insuring Organization provides for or arranges for the provision of care and contracts on a prepaid capitated risk basis to provide a comprehensive set of services.

"Other" Managed Care Entity - "Other" Managed Care Entity is used if the plan is not considered either a PCCM, PHP, MCO or HIO.

Terms used in "Reimbursement Arrangement" Column

Full Capitation (FUL)- A plan is paid for providing services to enrollees solely through capitation.

Partial Capitation (PAR)- A plan is paid for providing services to enrollees through a combination of capitation and fee-for-service reimbursements.

Fee-For-Service (FFS)- A plan or Primary Care Case Manager is paid for providing services to enrollees solely through fee-for-service payments plus in most cases, a case management fee.
