# Weekly Report: Influenza Summary Update - Nov. 14

During week 45 (November 2-8, 2008), a low level of influenza activity was reported in the United States. Forty (1.7%) specimens tested by U.S. World Health Organization (WHO) and National Respiratory and Enteric Virus Surveillance System (NREVSS) collaborating laboratories, and reported to CDC/Influenza Division, were positive for influenza. The proportion of deaths attributed to pneumonia and influenza (P&I) was below the epidemic threshold. The proportion of outpatient visits for influenza-like illness (ILI) was below national and region-specific baseline levels. One state reported local influenza activity; 15 states and Puerto Rico reported sporadic influenza activity; 34 states and the District of Columbia reported no influenza activity.

## **Healthcare Facility Infection Control**

National U.S. Inpatient Healthcare Facility Clostridium difficile Survey - APIC - Nov. 11

The APIC survey, the largest, most comprehensive of its kind, presents a one-day snapshot in time of the prevalence of *C. difficile* infection (CDI) in American hospitals. APIC's 12,000 members collected data about all of their CDI patients on one day between May and August 2008. Survey results were collected from 12.5% of all medical facilities in the U.S. that care for virtually every type of patient, including those at acute care, cancer, cardiac, children's, long-term care and rehabilitation hospitals. A total of 1,443 patients were identified with CDI from among the 648 participating hospitals. http://www.apic.org/AM/Template.cfm

Alabama Firm Recalls Hot Dog Products For Possible *Listeria* Contamination - USDA - Nov. 8 R. L. Zeigler Co., Inc., a Selma, Ala., firm, is recalling approximately 28,610 pounds of hot dog products that may be contaminated with *Listeria monocytogenes*. The hot dog products were produced on Sept. 22, and were sent to food service institutions and retail establishments in Alabama, Florida, Georgia, Mississippi, and Tennessee. The problem was discovered by the Georgia State Department of Agriculture through microbiological testing. FSIS has received no reports of illnesses associated with consumption of this product.
