

Food, Conservation and Energy Act of 2008 (2008 Farm Bill)



Section 4211(a) - USDA may purchase bison meat from Native American bison producers and producer-owned cooperatives of bison ranchers, subject to the appropriation of funds



Section 4211(a) - Traditional/Locally Grown Food Fund

- Authorizes \$5 million per year for the purchase of traditional and locally-grown foods for FY 2008-2012, subject to the appropriation of funds
- USDA shall define "traditional" & "locally-grown"

Section 4211(a) - Traditional/Locally Grown Food Fund

- Where practicable, at least 50% of the food must be from Native American producers
- USDA must conduct a survey of program participants to determine which foods are desired most
- USDA must report to Congress annually on the activities of the Traditional and Locally-Grown Food Fund

Section 4211(a) - Those individuals disqualified from FDPIR for an intentional program violation (IPV) are also disqualified from the Food Stamp Program



- Section 4211(b) Requires USDA to report to Congress by November 22, 2008 on:
- the process for determining the food package
- the extent to which it addresses the needs of low-income Native Americans compared to food stamps
- the extent to which it meets the 2005 Dietary Guidelines for Americans

Section 4211(b) report to Congress:

- the extent to which the food package meets the nutritional/health challenges specific to Native Americans
- the extent to which the food package is limited due to distribution costs or challenges in infrastructure
- plans to revise the food package to conform to the Dietary Guidelines (including costs)
- the rationale, if no changes are planned

FY 2008 Appropriation

■ FNS received a \$7.7 million increase in FDPIR administrative funds in FY 2008

FY 2007 FY 2008 \$27 million \$34.7 million

Congress specified that the funds were to be used to address inequities in the allocation of funds and equipment and facility improvement needs

FY 2008 Bison Purchases

The Senate Appropriations Committee Report (Senate Report 110-134) "encouraged USDA to continue the purchase of bison," but funds were not appropriated in FY 2008 to support these purchases

New Funding Methodology

- FDPIR Funding Work Group began meeting in May 2005
- 16 members (changed over time) and a facilitator
 - □ 10 representatives from NAFDPIR Board and ITO/State Program Directors
 - 6 representatives from FNS-HQ and Regional Office FDPIR staff

New Funding Methodology

- Work Group's final recommendation to FNS was issued on October 19, 2007
- FNS announced the new funding methodology on October 31, 2007, with a request for comments
- The new funding methodology is a modification of one of the Work Group's proposals
- It allocates funds to the FNS Regional Offices based on two weighted factors
- The Regional Offices then negotiate with each ITO and State agency on their individual budgets and allocate funds accordingly

FY 2008 Funding Methodology

- FDPIR received \$34.7 million in FY 2008 administrative funding to address, in part, inequities in funding (a \$7.7 million increase)
- The new program in Alaska was not included in the funding methodology in FY 2008 -\$1 million had been earmarked for Alaska in the FY 2008 President's Budget Request based on Alaska's budget estimates

FDPIR received \$1 million in FY 2008 to:

"enhance the nutritional knowledge of FDPIR participants and foster positive lifestyle changes for eligible household members, through intensive integrated nutritional education interventions"



- On January 10, 2008, FNS announced its intent to provide grants to ITOs and State agencies
- FNS received 20 proposals
- A technical review committee reviewed the proposals. The committee was comprised of impartial Nutritionists from FNS' National Office, who do not work with FDPIR
- 12 proposals were approved

Types of Approved Projects:

- Cooking classes on how to prepare commodity foods using spices & seasonings instead of salt
- Cooking classes on traditional cooking with local produce
- Cook-off contest and nutrition education event
- Classes on food safety
- Producing culturally relevant nutrition education materials (e.g., DVDs, cookbooks, resource kit, calendars with nutritional messages, posters)
- Developing curriculum & materials for teaching FDPIR households how to garden, and using the gardens to demonstrate the health benefits of increased fruit & vegetable consumption

- This is in addition to the \$1 million in the FY 2009 President's Budget for Nutrition Education Grants



FNS' Responses to 2007 NAFDPIR Resolutions



FNS' Responses to 2007 NAFDPIR Resolutions

- NAFDPIR passed three Resolutions at the 2007 annual conference
- The 2007 Resolutions were sent to Laura Castro, Chief, Policy Branch, on June 26, 2007
- FNS responded on August 17, 2007

"...NAFDPIR does hereby request USDA to raise the income guide rate for all participants to 130% of poverty to correspond to that of CSFP and that for the elderly, living on fixed incomes the income guide rate be raised to 185% of poverty."

FNS' Response:

- The FDPIR net income standard is set at 100% of the Federal Poverty Guideline adjusted by the appropriate food stamp standard deduction for each household size
- FDPIR uses the same net income standards as the Food Stamp Program (which are set by Congress)
- Since FDPIR was established by Congress as an alternative to the Food Stamp Program, FNS believes that it is appropriate that FDPIR continues to use the income standard established for the Food Stamp Program

"...NAFDPIR does recommend that in the upcoming FY 2008 agriculture appropriations, Congress should provide the funds required for administration to comply with the law. The funding should be sufficient to permit Tribes to acquire and maintain the equipment required to handle and distribute all commodities...

"... The appropriations committee should explicitly remove any restrictions on the open-ended match for administrative costs. The committee should instruct USDA to comply with the authorizing statute and follow its own regulations regarding administrative matching, by providing a minimum 75% match to all Tribes (and by allowing Tribes unable to meet this match to apply for additional assistance in covering the programs operating costs."

FNS' Response:

- This Resolution contains recommendations to Congress and it is not appropriate for FNS to respond on behalf of Congress
- In FY 2008, FNS received an increase of nearly \$7.7 million in FDPIR administrative funding

"...NAFDPIR does request that USDA/FNS allow for carryover funds to be utilized by ITO's within a set time for the purpose of delivery services to Tribal citizens participating in the Food Distribution Program."

FNS' Response:

- FNS does not have authority to allow carryover of funds from one fiscal year to the next
- FDPIR administrative funding is allowanced from the Food Stamp Program account
- By law, these funds must be obligated within the fiscal year they are appropriated
- Recent levels of unspent funds have been low



 - ✓ Not enough beef in product
- Dec 2007-Feb 2008: Pinnacle looks into complaint/sends product to ITO for sampling

 - 38% Fair

Handling Questionable Product

- Isolate the product
- Clearly mark the cases so it is not further distributed; quarantine if necessary
- Properly dispose of product immediately if it leaks, is infested, or otherwise compromises remaining inventory
- Take digital photos if possible and send electronically to FNS-HQ
- Contact local health inspector, if necessary

Information Required to Process Complaint

- Commodity Code and Title (e.g., A059 beans green 300)
- Description of problem & any reports of sickness or injury from product
- Requisition Number (found in ECOS and on your Bill of Lading) "req1234567"
- Date you received the commodity
- Quantity of product involved

Information Required to Process Complaint

- Quantity and physical address (no P.O. boxes) of remaining product in inventory
- Contract number and other identifying information on outer carton
- Contact Information: Name, Telephone Number, Fax Number, E-mail Address
- Direct Shipments only (e.g., Navajo Nation) include delivery order number and notice to
 deliver number (e.g., A059304J001 and
 VD02200001)

Not for the Hotline...

- No advanced paperwork or 24 hour notice
- Jumbled loads or broken pallets
- Inappropriate driver behavior
- Late deliveries, missing or damaged items

Instead you should contact...

- Multi-Food Orders: KCCO contracting representative (1-816-926-2604) or Regional Office
- Direct Deliveries: Refer to Notice to Deliver for KCCO specialist
- Keep Regional Office in the loop



Complaint Resolution Process

- Complaint is received by FNS-HQ complaint team via hotline/fax/email
- FNS-HQ acknowledges receipt of complaint from ITO/States via email or telephone, verifies information, and requests additional information if necessary
- FNS-HQ enters complaint into an automated complaint tracking system
- FNS-HQ determines if an isolated incident or trend

Complaint Resolution Process

- Complaints transmitted to contracting officer for review (FSA-KCCO or AMS)
- AMS or FSA conducts investigation and contacts the vendor for appropriate action
- Contracting officer provides response to FNS-HQ
- Complaint team will contact ITO/States with a resolution and complaint is closed

Factors That Slow The Process...

- Complaints are sent to Regional Office instead of FNS-HQ
- Incomplete information (e.g., requisition number, etc.)
- Delayed response from vendor

Regulations

Proposed Rule Coming Soon!

- Conform FDPIR resource standard limits to Food Stamp Program:
 - □ \$3,000 for all households with at least one elderly or disabled member;
 - □ \$2,000 for all other households;
 - Annual adjustments for inflation starting
 FY 2009 (tied to increases in the Consumer Price Index)

Regulations

- Add resource exclusion of \$1,500 for a pre-paid funeral arrangement for each household member
- Allow households that have all elderly and/or disabled members to be certified for up to 24 months

Management Evaluations (ME)

- FDPIR, TEFAP, and CSFP MEs will be conducted on an as needed basis, to allow the FNS Regional Administrators to best manage their workload
- Regional Offices determine which ITOs
 & State agencies will be reviewed each
 year and the scope of each review

Management Evaluations (ME)

- FNS Regional Offices tailor MEs based on the level of risk and Regional Office resources:
 - Some review all 12 areas; others target areas based on vulnerabilities identified in past MEs
 - Some conduct full onsite reviews; others are incorporating desk reviews

ERS/Urban Institute Study Update

- USDA Economic Research Service (ERS) conducts independent research of USDA programs
- ERS contracted with Urban Institute to conduct a study to determine:
 - whether FDPIR serves different individuals or meets different needs than the Food Stamp Program; and
 - how well FDPIR compares to the Food Stamp Program in addressing American Indian health and nutrition issues

- Study design to involve:
 - Interviews with local FDPIR and FSP administrators
 - Visits to certification offices,
 distribution sites, and warehouses
 - Focus groups with Native American participants in FDPIR and FSP

- Topics to be explored:
 - Participant recommendations for improving FDPIR and FSP
 - Participants concerns about healthy diets
 - Nutrition education and health promotion
 - Staff recommendations for improving access to healthy foods and traditional foods

- Topics to be explored:
 - Coordination between FDPIR and FSP
 - Participant knowledge and perceptions of FDPIR and FSP
 - Participant experience in FDPIR and FSP and factors affecting participation
 - Participant use of other food assistance programs

- At last year's conference, you met some of the Urban Institute researchers and they talked about their study plan
- At this point, they have completed 3 of 4 site visits:
 - □ Fond du Lac/Mille Lacs
 - □ Lower Brule/Crow Creek
 - □ Chickasaw/Choctaw
- The final report is expected June 2009
