

**AMENDMENT TO H.R. 1**  
**OFFERED BY MR. BUYER OF INDIANA**

At the end of division B, add the following new title  
(and revise the table of contents accordingly):

**1 TITLE VIII—VETERANS AFFAIRS**

**2 SEC. 8001. HOMELESS WOMEN VETERANS AND HOMELESS**  
**3 VETERANS WITH CHILDREN REINTEGRATION**  
**4 GRANT PROGRAM.**

**5 (a) APPROPRIATION.**—Of the amounts appropriated  
**6** under this Act, \$10,000,000 is for the homeless women  
**7** veterans and homeless veterans with children reintegration  
**8** grant program under section 2021A of title 38, United  
**9** States Code, as added by subsection (b).

**10 (b) HOMELESS WOMEN VETERANS AND HOMELESS**  
**11 VETERANS WITH CHILDREN REINTEGRATION GRANT**  
**12 PROGRAM.**—

**13 (1) GRANT PROGRAM.**—Chapter 20 of title 38,  
**14** United States Code, is amended by inserting after  
**15** section 2021 the following new section:

1 **“§ 2021A. Homeless women veterans and homeless**  
2 **veterans with children reintegration**  
3 **grant program**

4 “(a) GRANTS.—Subject to the availability of appro-  
5 priations provided for such purpose, the Secretary of  
6 Labor shall make grants to program and facilities that  
7 the Secretary determines provide dedicated services for  
8 homeless women veterans and homeless veterans with chil-  
9 dren.

10 “(b) USE OF FUNDS.—Grants under this section  
11 shall be used to provide job training, counseling, place-  
12 ment services (including job readiness and literacy and  
13 skills training) and child care services to expedite the re-  
14 integration of homeless women veterans and homeless vet-  
15 erans with children into the labor force.

16 “(c) REQUIREMENT TO MONITOR EXPENDITURES OF  
17 FUNDS.—(1) The Secretary of Labor shall collect such in-  
18 formation as that Secretary considers appropriate to mon-  
19 itor and evaluate the distribution and expenditure of funds  
20 appropriated to carry out this section. The information  
21 shall include data with respect to the results or outcomes  
22 of the services provided to each homeless veteran under  
23 this section.

24 “(2) Information under paragraph (1) shall be fur-  
25 nished in such form and manner as the Secretary of Labor  
26 may specify.

1           “(d) ADMINISTRATION THROUGH THE ASSISTANT  
2 SECRETARY OF LABOR FOR VETERANS’ EMPLOYMENT  
3 AND TRAINING.—The Secretary of Labor shall carry out  
4 this section through the Assistant Secretary of Labor for  
5 Veterans’ Employment and Training.

6           “(e) BIENNIAL REPORT TO CONGRESS.—The Sec-  
7 retary of Labor shall include as part of the report required  
8 under section 2021(d) of this title an evaluation of the  
9 grant program under this section, which shall include an  
10 evaluation of services furnished to veterans under this sec-  
11 tion and an analysis of the information collected under  
12 subsection (c).

13           “(f) AUTHORIZATION OF APPROPRIATIONS.—(1)  
14 There are authorized to be appropriated to carry out this  
15 section \$10,000,000 for each fiscal year.

16           “(2) Funds appropriated to carry out this section  
17 shall remain available until expended. Funds obligated in  
18 any fiscal year to carry out this section may be expended  
19 in that fiscal year and the succeeding fiscal year.”.

20           (2) CLERICAL AMENDMENT.—The table of sec-  
21 tions at the beginning of such chapter is amended  
22 by inserting after the item relating to section 2120  
23 the following new item:

“2021A. Homeless women veterans and homeless veterans with children re-  
integration grant program.”.
