


ARTICLES OF INCORPORATION

of

AFRICAN - AMERICAN INSTITUTE, INC.



For the purpose of forming a non-profit corporation under the laws of the State of Alabams, and any act amending, supplementing or substituting for the same laws, the undersigned do adopt this Certificate of Incorporation and upon due execution, acknowledgement, filing and recording hereof as providing by the law, shall constitute a body corporate.

ARTICLE 1.

NAME

1.1 The name of the Corporation shall be AFRICAN-AMERICAN INSTITUTE, INC.

ARTICLE II.

PRINCIPAL OR REGISTERED OFFICE

2.1 The location of the principal or registered office of the Corporation in the State of Alabama shall be 1614 3rd Avenue North, Birmingham, Alabama 35203.

ARTICLE III.

- 3.1 The purpose and objects for which the corporation is formed are:
- (a) to conduct any and all lawful business for which corporations may be organized under the Alabama Non-Profit Corporation Act and within the meaning of Section 501(c)3 of the Internal Revenue Code.
- (b) to promote and encourage positive solutions to the issues and concerns of the African-American community; to identify, define, and develop solutions; to engage in research; be it educational, scientific, or cutural; and to otherwise deal in any and all matters of concern to the African-American community.
- 3.2 The objects and purposes specified in each subsection of Section 3.1 shall, unless otherwise expressly provided, be in no ways limited by reference to, or inference

from, the terms of any other subjection of Section 3.1, each of the subsections being regarded as creating independent objects and purposes. All words, phrases, and clauses appearing in this Article III are used in their broadest sense and shall be so construed.

ARTICLE IV.

SPENOS

- 4.1 The Corporation shall have the capacity to do all things to the same extent as a natural person might or could do in any part of the world, as principal, agents, contractors, or otherwise, within or outside the State of Alabama.
- 4.2 The Corporation shall have and may exercise the powers given corporations by the Non-Profit Corporation Act and by any other law of the State of Alabama as if such powers were set forth in full herein.
- 4.3 The Objects and purposes set forth in Article III shall be construed as powers as well as objects and purposes, and the Corporation shall have and may exercise such powers as if such powers were set forth in full herein.
- 4.4 The Corporation shall have and may exercise all powers as shall enable it to do each and everything necessary, suitable, convenient, advisable, expedient or proper for the accomplishment of any or all purposes and the attainment of any or all of the objects set forth in Article III.
- 4.5 The Corporation shall have and may exercise all powers set forth in any other article of the certificate of incorporation, including, without limiting the generality of the foregoing, any and all powers set forth in Article III.
