**ROLL CALL VOTE # 51**

**BILL:** H.R. 1108, the “Family Smoking Prevention and Tobacco Control Act”, as approved by the Subcommittee on Health on March 11, 2008.

**MOTION:** An amendment to H.R. 1108, as amended, by Mr. Stearns, No. 5, to direct the Secretary to ensure there is no delay in the approval of multiple sclerosis (MS) drugs as a result of carrying out fast track research and approval of products for smoking cessation.

**DISPOSITION: NOT AGREED TO**, by a roll call vote of 18 yeas to 27 nays.
