13 process determined by the Corporation through

15 be eligible for a summer of service educational
16 award of not more than \$500 (or, at the discre-
17 tion of the Chief Executive Officer, not more
18 than \$1,000 in the case of a participant who is
19 economically disadvantaged) from funds depos-
20 ited in the National Service Trust and distrib-
21 uted by the Corporation as described in section
22 148; and

23 “(D) subject to the limitation that a stu-
24 dent may not receive more than 2 summer of

1 service educational awards from funds deposited
2 in the National Service Trust; and”.

3 sistent with the restriction in subsection (b), the
4 Corporation may provide fixed amount grants on a
5 competitive basis to up to 10 State Commissions to
6 support member-selected approved national service
7 positions.

8 “(2) LIMITATION.—The Corporation shall
9 award grants under paragraph (1) to support not
10 more than 500 approved national service positions
11 among the participating States.

12 “(b) LIMITS ON CORPORATION GRANT FUNDS.—

13 “(1) IN GENERAL.—Grants awarded under sub-
14 section (a)(1) shall not exceed \$600 per individual
15 enrolled in an approved national service position
16 under this section.

17 “(2) USE OF GRANT FUNDS.—Grants received
18 by State Commissions under subsection (a)(1)—

19 “(A) shall not be distributed to organiza-
20 tions receiving participants with approved na-
21 tional service positions under this section; and

22 “(B) may—

23 “(i) be used for oversight activities
24 and mechanisms for the service sites as de-

1 terminated by the State Commission or the
2 Corporation, which may include site visits;

3 “(ii) be used for activities to augment
4 the experience of AmeriCorps participants
5 in approved national service positions
6 under this section, including activities to
7 engage such participants in networking op-
8 portunities with other AmeriCorps partici-
9 pants; and

10 “(iii) be used for recruitment or train-
11 ing activities for participants in approved
12 national service positions under this sec-
13 tion.

14 “(c) STATE COMMISSION APPLICATION.—

15 “(1) IN GENERAL.—A State Commission desir-
16 ing to receive a grant under subsection (a)(1) shall
17 submit an application to the Corporation at such
18 time, in such manner, and containing such informa-
19 tion as the Corporation shall determine appropriate.

20 “(2) APPROVAL.—The Corporation shall ap-
21 prove each application under paragraph (1) in ac-
22 cordance with section 130(d).

23 “(d) SELECTION OF PARTICIPANTS.—

24 “(1) APPLICANTS.—Participants desiring to re-
25 ceive an approved national service position under

1 this section shall submit an application to the State
2 Commission at such time and in such manner as the
3 State Commission determines appropriate. The ap-
4 plication shall contain—

5 “(A) a position description that includes—

6 “(i) the unmet human, educational,
7 public safety, or environmental need or
8 needs that will be met by the participant;
9 and

10 “(ii) a description of the activities and
11 responsibilities that will be carried out by
12 the participant;

13 “(B) a description of the organization op-
14 erating the service site where the applicant in-
15 tends to complete the service described in sub-
16 paragraph (A);

17 “(C) a description of the support that will
18 be provided by the organization to the partici-
19 pant to complete the activities described in sub-
20 paragraph (A);

21 “(D) the evidence of community support
22 for the activities described in subparagraph (A);

23 “(E) a certification from the organization
24 operating the service site that the organization

1 is accepting the participant to perform the serv-
2 ice outlined in subparagraph (A);

3 “(F) a certification from the organization
4 operating the service site that the organization
5 satisfies qualification criteria established by the
6 Corporation or the State Commission, including
7 standards relating to organizational capacity, fi-
8 nancial management, and programmatic over-
9 sight; and

10 “(G) any other information that the Cor-
11 poration and the State Commission deems nec-
12 essary.

13 “(2) RESIDENCY.—A participant may apply for
14 approved national service positions under this sec-
15 tion in States other than the State in which the par-
16 ticipant resides.

17 “(e) ORGANIZATION REQUIREMENTS.—The Corpora-
18 tion and the State Commissions shall ensure that the or-
19 ganizations receiving participants with approved national
20 service positions under this section—

21 “(1) maintain not more than 5 full-time staff
22 and not more than 5 part-time staff; and

23 “(2) are not duplicating service provided by an
24 existing AmeriCorps grantee in the same commu-
25 nity; and

1 “(3) are located in a community where no
2 Intermediary AmeriCorps grants recipient is oper-
3 ating; and

4 “(4) have not applied to receive assistance
5 under this subtitle.

6 “(f) FAILURE TO COMPLY.—If an organization re-
7 ceiving a participant with an approved national service po-
8 sition under this section fails to comply with terms and
9 conditions established by the State Commission and the
10 Corporation—

11 “(1) the organization shall not be eligible to re-
12 ceive such a participant, or receive an AmeriCorps
13 grant under section 121, for not less than 5 years;
14 and

15 “(2) the State Commission shall have the right
16 to remove such a participant from the organization
17 and relocate that individual to another site.

18 “(g) RECEIPT OF FINANCIAL ASSISTANCE.—An or-
19 ganization that receives participants with approved na-
20 tional service positions under this section shall not be con-
21 sidered a recipient of Federal financial assistance based
22 on receiving such participants.

23 “(h) DEFINITION.—For the purpose of this section,
24 the term ‘Intermediary AmeriCorps grants recipient’
25 means any organization that serves as a conduit between

1 the Corporation and other unaffiliated organizations oper-
2 ating service sites.

9 aging on—

10 “(i) a marketing outreach plan to
11 businesses;

13 tions;

14 “(iii) the State’s Department of Edu-
15 cation; and

16 “(iv) other State agencies; and

17 “(C) recommendations for civic engage-
18 ment and multigenerational activities, such
19 as—

20 “(i) early childhood education, family
21 literacy, and after school programs;

22 “(ii) respite services for older adults
23 and caregivers; and

1 “(iii) transitions for members of the
2 Baby Boom generation and older adults to
3 purposeful work in their post career lives.

5 plan shall incorporate the current knowledge base
6 regarding—

7 “(A) the economic impact of older workers’
8 roles in the economy;

9 “(B) the social impact of older workers’
10 roles in the community; and

11 “(C) the health and social benefits of ac-
12 tive engagement for members of the Baby
13 Boom generation and older adults.

14 “(4) PUBLICATION.—The State plan must be
15 made public and be transmitted to the Chief Execu-
16 tive Officer.”; and

13 **“(a) PLANNING STUDY.—**The Corporation for Na-
14 tional and Community Service shall conduct a study to
15 identify—

16 **“(1) specific areas of need for veterans;**

1 “(2) how existing programs and activities car-
2 ried out under the national service laws could better
3 serve veterans and veterans service organizations;

4 “(3) gaps in service to veterans;

5 “(4) prospects for better coordination of serv-
6 ices;

7 “(5) prospects for better utilization of veterans
8 as resources and volunteers; and

9 “(6) methods for ensuring the efficient financial
10 organization of services directed towards veterans.

11 “(b) CONSULTATION.—The study shall be carried out
12 in consultation with veterans’ service organizations, the
13 Department of Veterans Affairs, State veterans agencies,
14 the Department of Defense, and other individuals and en-
15 tities the Corporation considers appropriate.

16 “(c) REPORT.—Not later than 1 year after the date
17 of the enactment of this section, the Corporation shall sub-
18 mit to the Committee on Education and Labor of the
19 House of Representatives and the Committee on Health,
20 Education, Labor, and Pensions of the Senate a report
21 on the results of the planning study required by subsection
22 (a), together with a plan for implementation of a pilot pro-
23 gram using promising strategies and approaches for better
24 targeting and serving veterans.

1 “(d) PILOT PROGRAM.—From amounts made avail-
2 able to carry out this section, the Corporation shall de-
3 velop and carry out a pilot program based on the findings
4 in the report submitted under subsection (c).

5 “(e) AUTHORIZATION OF APPROPRIATIONS.—There
6 are authorized to be appropriated to carry out this section
7 such sums as may be necessary for each of fiscal years
8 2008 through 2012.”.

13 “(B) NON-FEDERAL CONTRIBUTION.—In
14 providing for the remaining share of the cost of
15 carrying out such a program, each recipient of
16 a grant under this part—

17 “(i) shall provide for such share
18 through a payment in cash or in kind, fair-
19 ly evaluated, including facilities, equip-
20 ment, or services; and

1 “(ii) may provide for such share
2 through State sources or local sources, in-
3 cluding private funds or donated services.”.

7 “(d) INCENTIVE GRANTS.—The incentive grants re-

9 programs receiving assistance under this title, subject to
10 the following:

11 “(1) Such grants (which may be fixed-amount
12 grants) shall be grants in an amount equal to \$300
13 per volunteer enrolled in the program, except that
14 such amount shall be reduced as necessary to meet
15 the goals of this section.

16 “(2) Such a grant shall be awarded to a pro-
17 gram only if the program—

18 “(A) exceeds performance measures estab-
19 lished under section 179 of the National and
20 Community Service Act of 1990;

21 “(B) provides non-Federal matching funds

3 with measurable objectives meeting community

7 fined in section 101 of the National and Com-
8 munity Service Act of 1990, than were enrolled
9 in the program during the previous fiscal year.

10 “(3) For each such grant, the Corporation shall
11 require the recipient to provide matching funds of
12 70 cents from non-Federal sources for every \$1 pro-
13 vided under the grant.

14 “(4) Such a grant shall be awarded to a pro-
15 gram only if the program submits, at such time and
16 in such manner as the Corporation may reasonably
17 require, an application that contains—

18 “(A) a demonstration that the program
19 has met the requirements of paragraph (2);

20 “(B) if applicable, a plan for innovative
21 programs as described in paragraph (6)(B)(ii);

22 “(C) a sustainability plan that describes
23 how the program will maintain the activities de-
