eSNAP – Edit Business – Project/Performance Sites

The Project/Performance Site List Page collects information for each Project/Performance site as required by the Federal Financial Accountability and Transparency Act (FFATA). The following changes were made to this screen:

- The "DUNS or DUNS + 4" field now accepts 9 or 13 digits to accommodate DUNS or DUNS+4 designation. Please enter either 9 digits for DUNS or 13 digits for the DUNS with extension without dashes. (See Figure 6, number 1)
- **2.** The "**Country**" drop-down field is now located at the top of the screen. The Country selected determines which of the remaining fields will be required. For example, the State field is only required when the Country is United States. (*See Figure 6, number 2.*)
- **3.** The "**Primary Project/Performance Site**" checkbox provides the ability to designate a site as Primary within the eSNAP module. (*See Figure 6, number 3a.*) This designation appears next to the site name in the Project Performance sites list at the bottom of the screen. (*See Figure 6, number 3b.*)

- **4.** The third and fourth lines of the "**Address**" fields have been disabled. These read-only fields remain on the screen but will not appear in the generated Progress Report Face Page or eSNAP report, nor will they show on the Project Performance Sites list at the bottom of the screen. (*See Figure 6, number 4.*) Please ensure all relevant data is contained within Address lines 1 and 2.
- **5.** "State" and "Province" are now separate fields. (*See Figure 6, number 5.*) Province is a free-form text field for all Countries except for Canada, which has a drop-down menu.
- 6. A "Congressional District" field has been added to the screen. This is a required field when the country is designated as United States and the selection for the State drop down is not a US Territory. The field text is hyperlinked and links to http://congress.org/congressorg/dbq/officials/?lvl=L. (See Figure 6, number 6.)

The eSNAP Report and the Progress Report Face Page reflect the changes made throughout Commons eSNAP screens.

ESNAP DEFECTS

eSNAP – Edit Business – Senior/Key Personnel

Two defects were fixed that originated from the **"Months Devoted to Project"** fields on the Senior/Key Personnel page.

Calendar Validation

Previously, eSNAP validations returned a message, 'No errors found on validation' when the PD/PI calendar months field was zero and all MPI months were blank. Now, eSNAP validations will return an error message if any one of the three **"Months Devoted to Project"** fields is less than zero.

Validation Error

eSNAP validations previously returned an error indicating that the value for calendar/summer/academic months must be greater than zero – even when the data shows the value to be greater than zero.

The validation has been corrected to not display the error when the data clearly indicates values greater than zero.
