#### PROMOTION TYPES

#### Temporary

-Pay Related

#### Permanent

 Promotion to a grade below which an officer shall not be reduced except for cause under applicable PHS Commissioned Corps regulations.



#### **Promotions based on T&E**

- Promotions based on the Training & Experience (T&E or TED):
  - Education, training or work experience that is creditable for purposes of establishing an officer's permanent grade at appointment or in determining an officer's eligibility for permanent promotion on or after original appointment
- T&E date is found on Call to Active Duty Orders

# Permanent Noncompetitive Promotions

- Applies to <u>Reserve Corps Officers</u> on Extended Active Duty
  - -Promotion eligible for O-2 and O-3
- Based on Training & Experience (T&E or TED)
  - After original appointment, Regular & Reserve Corps Officers must hold their temporary grade at least 1 year prior to being promoted to the same permanent grade.

#### Requirements for Permanent

- No pending or Adverse/Disciplinary Actions
- All Required COERs on file with Score of "C" or better
  - Liaison
- Current License on file (If required)
- Officer meets Force Readiness Standards at least ONE FULL QUARTER Before Eligible
- Cleared by Medical Affairs Branch (MAB)
