Formatta Egrants Server is a Web application that works in conjunction with Formatta Filler for preparing and submitting electronic grant applications to the NIH. Egrants Server makes preparing, managing, and submitting electronic grant applications simple. The features of the product allow for collaboration, administrative review, pre-submission validation, status checking, and information storage in profiles. Egrants Server assists the applicant through the entire submission process, from initial preparation until final receipt of the application by NIH.

Organizations registered with Formatta as a service provider can access Egrants Server through a secure Website. Larger organizations should consider installing the software at their own location.
