Background

The Committee Management User Group (CMUG) was established to provide a forum to discuss and to facilitate the resolution of any user difficulty with the CM Module; identify required modifications, identify training issues and requirements for users, provide recommendations to the eRA Advocate or eRA analyst, and identify any current or potential issues when shared functionality overlaps with other modules.

Membership

CMUG will include the eRA Advocate, the eRA analyst for the CM Module, and any HHS staff member interested in the CM Module including Committee Management Officers and Assistants, Grants/Contract Technical Assistants, Scientific Review Administrators, Lead Grants Technical Assistants, and SREA Officers and staff. Members of CMUG represent their respective NIH Institutes/Centers or HHS Operational Divisions on issues and specific courses of action. Members are responsible for ensuring communications and exchange of information between the CMUG and their respective organizations. The group selects the Chair each November for the following year.

Previous Member data—The GTAs in CSR and some Institutes/Centers have been told not to use "previous member" but to use "other member." Everyone needs to understand what data "previous member" pulls in and to check the date to see if the data can be used.
