While most European countries have accepted the results of alternative tests since the mid 1990s for the purpose of identifying and classifying chemicals that cause severe eye irritation, ICCVAM has taken the incomprehensible position that, regardless of the result of a non-animal test, "confirmatory" testing should be carried out on animals. According to ICCVAM, even chemicals that exhibit corrosive or severely irritating properties in vitro should still be dripped or smeared into rabbits' eyes "just to be sure."
