

EXECUTIVE SUMMARY REPORT ON OREGON HEALTH PLAN (OHP) UTILIZATION AND ENROLLMENT FOR MENTAL HEALTH SERVICES: OCTOBER 2006 THROUGH SEPTEMBER 2007

The Mental Health Organization (MHO) Utilization Quarterly Report for the period of October 1, 2006 through September 30, 2007, contains enrollment, unique served and hospitalization data. The data for this report were pulled April 8, 2008. All information came from the Division of Medical Assistance Programs' (DMAP) Decision Support/Surveillance and Utilization Review System (DSSURS) and is comparable to the report released in January 2008.

Population

- This report reflects only Medicaid members who were eligible, enrolled, and received mental health services during the report period.
- The acute care admission population is any enrolled Medicaid member who was admitted for inpatient psychiatric treatment.
- Those who are receiving mental health services and alcohol and drug treatment are included in this report.

Limitations

- This report does not include tests of the statistical significance of apparent differences among providers or across time periods.
- The report is a "snap-shot" in time for the specific report being created and is comparable to the report released in July 2007.
- Acute hospitalization data includes and is not limited to transfers from one facility to another and/or re-admitted within a 24-hour time frame.
- There is a 180-day lag between the times a service is delivered and the time the services is contractually required to be billed.

Formula

- The calculations for the unique enrollees and/or served is dividing the number of total enrollees by the number served within the same time period.
- The penetration rate, or percentage rate, is a general measure of access and is related to the utilization of services.

Report Schedule

This report is created on a quarterly basis.







FIGURE 4: TOTAL ALL QUARTERS: UNIQUE ENCOUNTERS: DIAGNOSTIC GROUPS






MHO UTILIZATION REPORT GLOSSARY

ADDICTIONS AND MENTAL HEALTH DIVISION (AMH):

The division office of DHS responsible for the administration of mental health services for the State of Oregon.

DIAGNOSIS CATEGORY:

Diagnosis categories are defined by the grouping of diagnoses in the most recent version of the American Psychiatric Association's Diagnostic and Statistical Manual (DSM).

ELIGIBLE:

An individual eligible for services under the OHP, but may not be enrolled into an MHO. Includes enrolled and fee-for-service.

ENCOUNTER:

An outpatient contact or Acute Inpatient Hospital Psychiatric Care admission for Covered Services provided to an OHP Member.

ENROLLED (ENROLLEE):

Eligible for the Oregon Health Plan (OHP) and enrolled in an MHO.

FEE-FOR-SERVICE (FFS):

Individuals who are eligible for the OHP, but are not enrolled with an MHO. This is also known as fee-for-service (FFS) or an "open card".

MENTAL HEALTH ORGANIZATION (MHO):

A Prepaid Health Plan under contract with DHS to provide Covered Services under the OHP Medicaid Demonstration Project and State Children's Health Insurance Program (SCHIP). MHOs can be FCHPs, CMHPs, or private MHOs or combinations thereof.

OREGON HEALTH PLAN (OHP):

Oregon's health care reform effort consisting of a Medicaid Demonstration Project, State Children's Health Insurance Program, an individual insurance program for persons excluded from health insurance coverage due to pre-existing health conditions, and a group insurance program for small businesses. One objective of this reform effort includes universal coverage for Oregonians. In the context of this report, OHP refers to all individuals on FFSMHO Utilization Report Glossary

MHO UTILIZATION REPORT GLOSSARY (Continued)

PERCENT ENROLLEES SERVED:

This is a general measure of access, but more related to utilization of services. It is a percentage calculated by summing the unique enrollees seen during a given time period and dividing that number by the total enrollees for that time period. For example, if there is 10,000 enrollees statewide in a given month and during that same month 500 of those enrollees receive services, the percent of enrollees served is 5%.

PERCENTAGE RATE:

A percent of the total enrollees that received services within a given time period.

SERVICE CATEGORY:

Service category is a descriptive grouping of service codes (BA, ECC, and CPT) that are similar procedurally.

UNIQUE SERVED:

Unduplicated number of individuals receiving mental health services.

UNIQUE ENCOUNTERS:

Unduplicated services received by an individual(s) within a specific time period. One individual may have had several services provided – each service would be part of the calculations.
