## Preface

This publication was originally issued in conjunction with an exhibit: "The United States Public Health Service: The Last Hundred Years," prepared to commemorate the centennial of the PHS Commissioned Corps in 1989.

In celebration of the bicentennial of the United States Public Health Service in 1998, a revision of the 1989 Bibliography has been compiled. This newly revised and updated bibliography is a selected list of sources relating to the history of the United States Public Health Service from its beginning in 1798 as the Marine Hospital Service. With the earlier bibliography serving as the foundation, it has been augmented by additional references from CATLINE (the Library's online book catalog), and HISTLINE (the history of medicine online), as well as other sources. It includes monographs and journal articles which are presented in four broad categories: general works; control of disease and delivery of health care; biomedical research; and regulation of food and drugs. This revision includes an additional 84 references and was prepared with assistance from the Office of the PHS Historian. It is not an exhaustive list but rather a preliminary guide to the subject.
