The Migratory Bird Conservation Commission

Sections 2 of the Migratory Bird Conservation Act of February 18, 1929 (Act), as amended, established the Migratory Bird Conservation Commission.

Section 2. A Commission to be known as the Migratory Bird Conservation Commission, consisting of the Secretary of the Interior; as Chairman; the Administrator of the Environmental Protection Agency; the Secretary of Agriculture; two Members of the Senate, to be selected by the President of the Senate; and two Members of the House of Representatives, to be selected by the Speaker, is created and authorized to consider and pass upon any area of land, water, or land and water that may be recommended by the Secretary of the Interior for purchase or rental under this Act and to fix the price or prices at which such area may be purchased or rented; and no purchase or rental shall be made

of any such area until it has been duly approved for purchase or rental by said Commission. Any Member of the House of Representatives who is a member of the Commission, if reelected to the succeeding Congress, may serve on the Commission notwithstanding the expiration of a Congress. Any vacancy on the Commission shall be filled in the same manner as the original appointment. The ranking officer of the branch or department of a State to which is committed the administration of its game laws, or his authorized representative, shall be a member ex officio of said Commission for the purpose of considering and voting on all questions relating to the acquisition, under said sections, of areas in his State. For purposes of said sections, the purchase or rental of any area of land, water, or land and water includes the purchase or rental of any interest in any such area of land, water, or land and water.

Approvals During Fiscal Year 2002

In Fiscal Year 2002, the Migratory Bird Conservation Commission approved the acquisition boundary at one national wildlife refuge. This refuge, totaling 16,437 acres, is the Red River National Wildlife Refuge in Caddo, Desoto, Red River and Natchitoches Parishes, Louisiana. It is authorized by Public Law 106- 300 and was established on August 22, 2002, with the acquisition of 3,857 acres. The Commission approved boundary additions, totaling 5,629 acres, to two refuges that were previously approved by the Commission. The Commission also approved the purchase price of 16,228 acres at 16 refuges and reapproved the price for fee lands at one refuge and leases at two refuges totaling 93,459 acres.

The Migratory Bird Conservation Fund

The Migratory Bird Conservation Fund provides the Department of the Interior with monies to acquire migratory bird habitat. There are four major sources of money for the Fund. The most well-known source is the revenue received from the sale of Migratory Bird Hunting and Conservation Stamps, commonly known as Duck Stamps, as provided for under the Migratory Bird Hunting and Conservation Stamp Act of March 18, 1934, as amended. The other three major sources include appropriations authorized by the Wetlands Loan Act of October 4, 1961, as amended; import duties collected on arms and ammunition; and receipts from the sale of refuge admission permits as provided for in the Emergency Wetlands Resources Act of 1986. The Fund is further supplemented by receipts from the sale of products from refuge lands and rights-of-ways across national wildlife refuges, the disposal of refuge lands, and reverted Federal Aid funds.

Two land acquisition programs are financed from the Migratory Bird Conservation Fund. The first purchases major areas for migratory birds under the authority of the Migratory Bird Conservation Act. Lands acquired through this program are considered and approved by the Migratory Bird

Conservation Commission. The second program acquires small natural wetlands and associated uplands located mainly in the Prairie Pothole Region of the upper Midwest. These lands, known as Waterfowl Production Areas, are acquired under the authority of the Migratory Bird Hunting and Conservation Stamp Act and do not require approval from the Commission.

During Fiscal Year 2002, the Department of the Interior obligated a total of \$19,514,319 for the acquisition of land and interests in land totaling 34,129 acres in major migratory bird conservation areas. An additional \$15,617,007 was obligated for projects in Waterfowl Production Areas totaling 58,156 acres.

A total of \$46,930,082 was available for obligation from the Migratory Bird Conservation Fund during Fiscal Year 2002. Obligations for all Migratory Bird Conservation Fund land acquisition functions during the fiscal year totaled \$46,531,702 (\$715,842 of which were from prior year recoveries). The total obligations equal 99 percent of the available funds.

New National Wildlife Refuge Boundary Approvals

In Fiscal Year 2002, the Migratory Bird Conservation Commission approved the acquisition boundary of one new refuge, the Red River National Wildlife Refuge in Caddo, Bossier, Desoto, Red River and Natchitoches Parishes, Louisiana. The Commission also approved the acquisition boundary of two national wildlife refuges that were previously established: the Blackwater National Wildlife Refuge in Dorchester County, Maryland; and the Trinity River National Wildlife Refuge in Liberty County, Texas.

Red River National Wildlife Refuge

Caddo, Bossier, Desoto, Red River, and Natchitoches Parishes, Louisiana

The Red River National Wildlife Refuge was authorized by Public Law 106-300 on October 13, 2000, and was established on August 22, 2002, under the Migratory Bird Conservation Act. The Secretary is authorized to acquire up to 50,000 acres in the project area which is located in northwest Louisiana along a 280-mile stretch of the Red River.

The Red River NWR will provide wintering habitat for mallards, pintails and wood ducks and contribute to the goals of the North American Waterfowl Management Plan. The bottomland hardwood forests of the Red River Valley have been almost totally cleared. Reforestation and restoration of native habitat will benefit a wide array of species. The Red River Valley is part of a major continental migration corridor for migratory birds funneling through the mid continent. The Red River NWR offers recreational, research and education opportunities for students, scientists, bird watchers, hunters and anglers.

The Commission approved the 16,437-acre boundary on June 12, 2002.

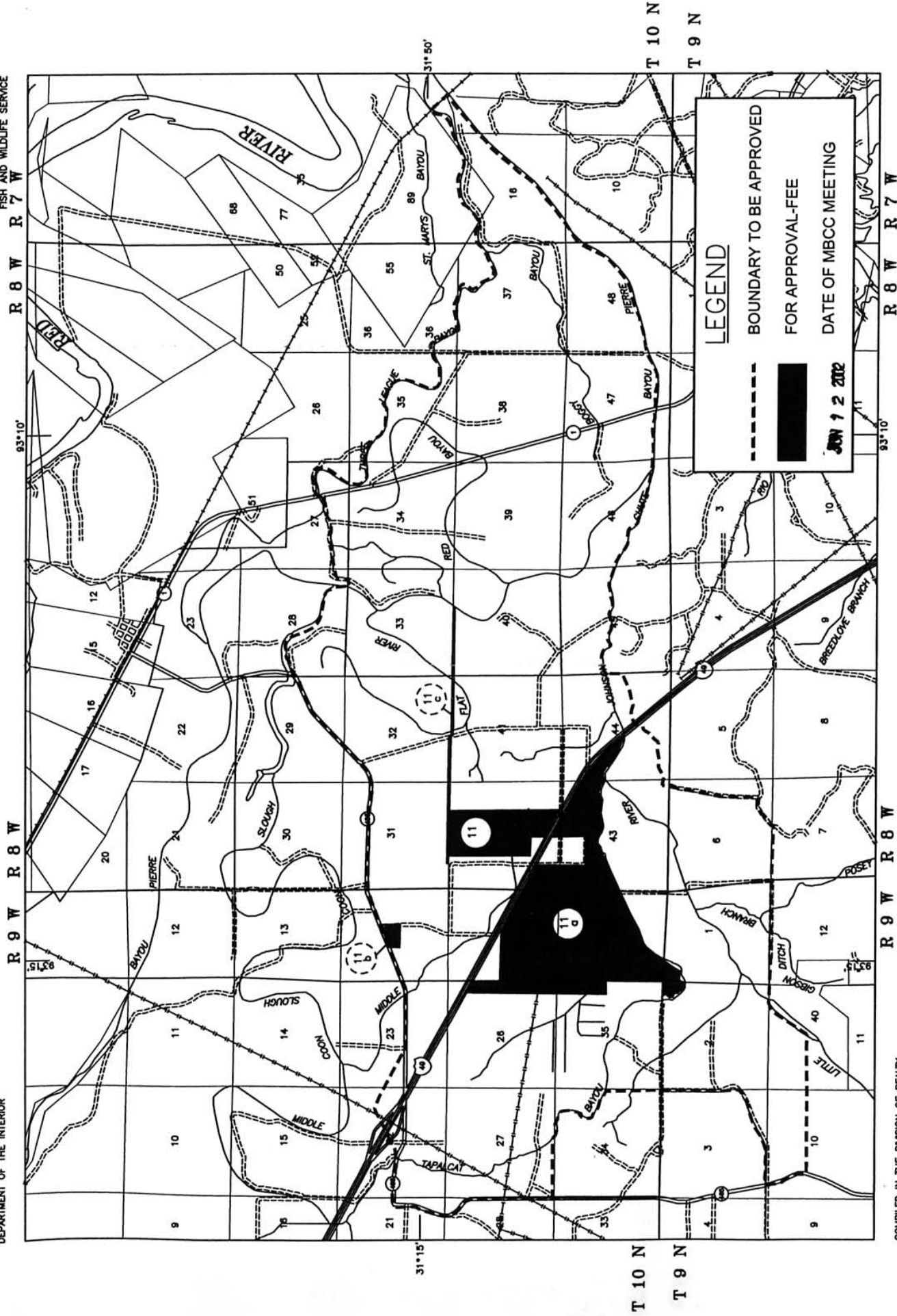

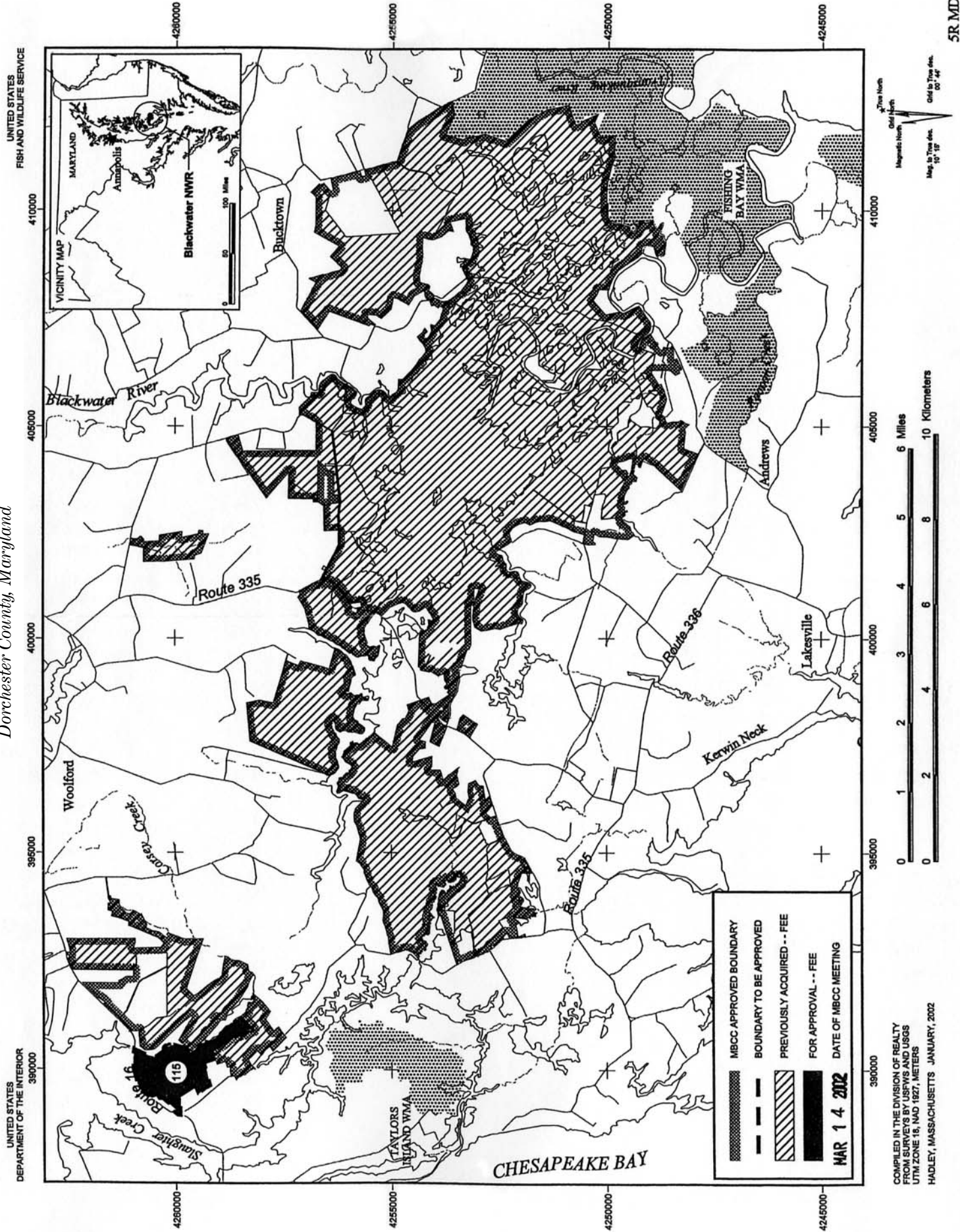
Blackwater National Wildlife Refuge
Dorchester County, Maryland

The Blackwater National Wildlife Refuge was established in 1932 as a waterfowl sanctuary. Lands were subsequently added through purchases and donations. The area around the Blackwater National Wildlife Refuge is undergoing major land use changes. Timber harvesting and land clearing for agricultural use are reducing the available habitat and degrading preservation of the refuge. The boundary expansion will aid in the preservation of the refuge and protect the highly productive and ecologically diverse wetlands from major environmental alternation and degradation associated with the saltwater intrusion.

The refuge is located approximately 14 miles south of Cambridge, Maryland, in south central Dorchester County. The addition includes approximately 500 acres located just south of Taylors Island Road and has over 500 feet of frontage on Parsons Creek. The area consists mostly of forested wetlands, interspersed with tidal waters, ponds and marsh. It provides nesting habitat for various waterfowl species, including black duck, mallard, blue-winged teal, gadwall and Canada geese. It also provides migration and wintering habitat for other waterfowl, such as pintail, green-winged teal, shovelers, mergansers, and tundra swans. Numerous species of other migratory birds, including the federally threatened bald eagle, songbirds, and webless waterbirds also utilize this area for nesting, roosting and foraging.

The Commission approved the 500 acre refuge boundary on March 14, 2002.

Trinity River National Wildlife Refuge
Liberty County, Texas

The Trinity River National Wildlife Refuge was established on January 3, 1994, with the purchase of 4,400 acres of bottomland hardwood and associated habitats using Land and Water Conservation Fund appropriations. On June 14, 1994, the Migratory Bird Conservation Commission approved the initial MBCC boundary for the refuge, encompassing 20,110 acres. Since 1994, the MBCC boundary was expanded to include another 4,325 acres.

The refuge is located in Liberty County, Texas, about 45 miles northeast of Houston. It was created to protect remnant bottomland hardwood forests and associated wetland habitats for migrating, wintering, and breeding waterfowl. It currently represents one of the few remaining high-quality areas for

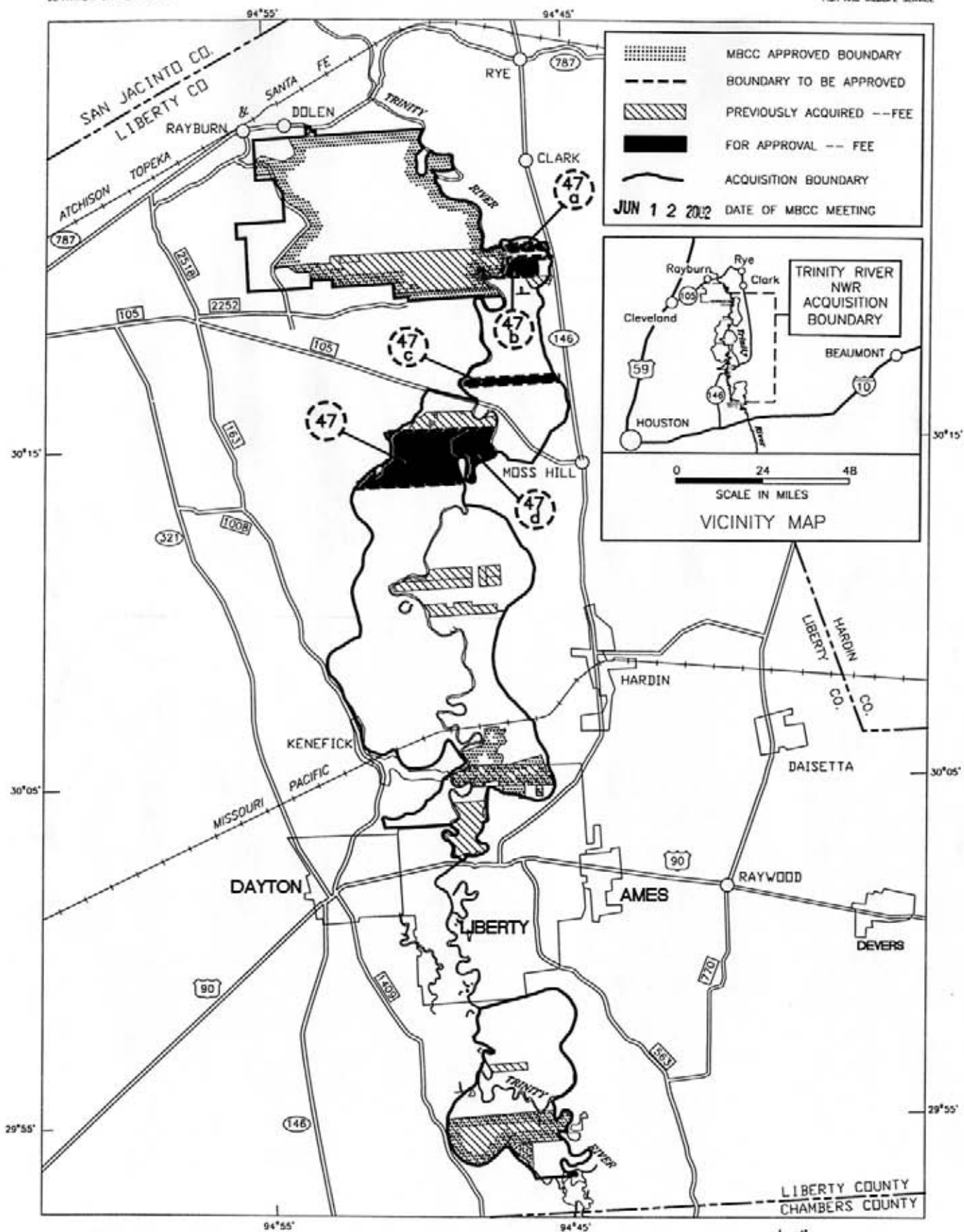
waterfowl in east Texas. The high variety of wetlands on the project area provide important foraging and/or roosting habitat for the wood duck, mallard, gadwall, widgeon, green and blue-winged teal, lesser scaup and mottled ducks. The mature cavity trees dispersed throughout the area also provide important nesting habitat for wood ducks and black-bellied whistling ducks. Large colonial waterbird rookeries are abundant in the many swamps, sloughs and oxbow lakes found here. The expanded boundary allows for the acquisition of tracts in the Tanner Bayou and Capers Ridge Focus Areas of the Lower Trinity River Floodplain Stewardship Program as well as the Texas Bottomland Hardwood Initiative, a component of the Lower Mississippi Valley Joint Venture.

The Commission approved the 5,129-acre addition to the refuge boundary on June 12, 2002.

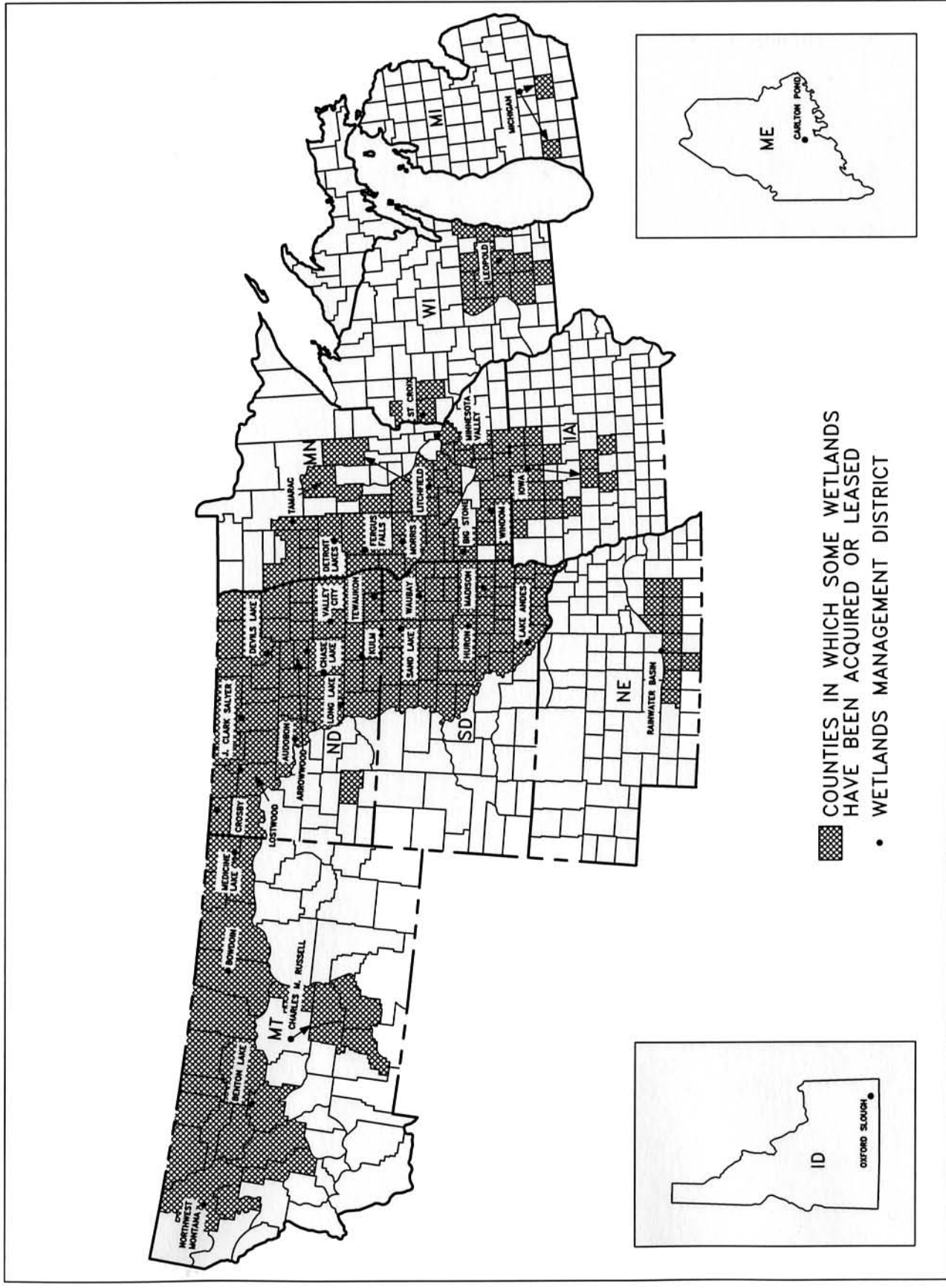

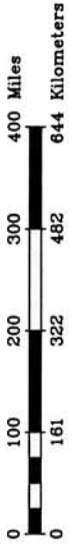

Notes on Tables One and Two

The information contained in this report includes those acquisitions and dispositions of land and interests therein that are purchased with Migratory Bird Conservation Fund monies or acquired under the authority of the Migratory Bird Conservation Act. It also includes other migratory bird areas such as those that are transferred to the Fish and Wildlife Service under the authority of Public Law 80-537 to carry out a migratory bird management program (these will appear on Table 1).

In an ongoing effort to improve data quality, the figures in Tables One and Two may show minor changes from previous annual reports. Lands in which the Service previously acquired a less-than-fee interest (leases and easements) may be purchased in fee during the year, and

the number of easement or lease acres will show a decrease and the number of purchased acres an increase. The acreage appearing in the Approvals and Summary of Land Acquisitions sections of this report will not appear in Tables One or Two until after the tracts are acquired and the funds are actually expended. Also, a newly approved refuge will not appear on Table One until the tracts are acquired.

North American Wetlands Conservation Fund (Summary) Fiscal Year 2002

The Migratory Bird Conservation Commission approved 101 standard wetland conservation project proposals for funding in Fiscal Year 2002 under the North American Wetlands Conservation Act. A total of \$74,531,874 from the North

American Wetlands Conservation Fund, together with \$261,153,404 in partner funds, are supporting 52 projects in the United States, 31 in Canada, and 18 in Mexico. The following tables provide summary and detailed allocation information.
