OCCUPATIONAL HISTORY (OC)

Now I'd like to review the calendar you completed, focusing on the kind of work you have done.

BRIEFLY REVIEW THE JOB/COMPANY COLUMN OF THE PERSONAL RESIDENCE AND WORK CALENDAR WITH S.

DETERMINE WHICH JOBS HELD AFTER 1945 WERE HELD FOR \geq 12 MONTHS AND PLACE A CHECK MARK NEXT TO THEM ON THE CALENDAR. THESE JOBS QUALIFY TO BE ENTERED IN CAPI.

BEFORE ENTERING JOB(S) IN CAPI, ASK OC-1.

OC-1. Have you held any summer jobs or part-time jobs for a total of at least 12 months that you have not reported on this calendar already? For example, a 3-month summer job that you held for 4 years.

AS NEEDED, ADD ADDITIONAL JOBS TO CALENDAR AND PLACE A CHECK MARK NEXT TO THEM.

SCRIPT 1

Now, I'm going to ask about your job. I will ask the questions on this card.

ENTER THE JOB START YEAR, TITLE, EMPLOYER, AND STOP YEAR, AND ASK OC-2 THROUGH OC-8.

SCRIPT 2

FOR MOST RECENT JOB, SAY:

Now, I'm going to ask about your jobs, starting with the most recent job and working backwards in time. For each job, I will ask the questions on this card. Let's start with your most recent job.

FOR EACH JOB AFTER THE MOST RECENT, SAY:
Now let's talk about your job as a (JOB) at (EMPLOYER) from (YEAR STARTED) to (YEAR STOPPED).

ENTER THE START YEAR, JOB, EMPLOYER, AND STOP YEAR, AND ASK OC-2 THROUGH OC-8 FOR EACH JOB, STARTING WITH THE MOST RECENT JOB AND WORKING BACKWARDS, IN REVERSE CHRONOLOGICAL ORDER, TO 1945.
