THE EARLY CHRONIC RESPIRATORY DISEASE PROJECT....

funded in July, 1969, is now fully operational after a preparatory phase for organization and coordination with the Breathmobile Program of the TB and Respiratory Disease Association of LAC. Project headquarters are in the 11-200 Wing of LAC-USC Medical Center; patients are seen in the Out-Patient Dept. of the Medical Center, where the pulmonary laboratory for the project is also located.

A Symposium to discuss various approaches and their merits in the prophylactic management of emphysema, chronic bronchitis and other obstructive lung diseases in their "presymptomatic stage" was held on October 18, 1969 and attracted an audience of 105 physicians from all over California.

The first printout of patients detected as having pulmonary abnormalities by the Breathmobile was received in mid-December and the various phases of the project are now in full swing. It was anticipated that during the first year of operation, 150 physicians might respond to the invitation to participate in the program, however, the acceptance to date has been almost four times greater. While pleased, Dr. Wilbur Y. Hallett, Project Director, is concerned with the project's ability to cope with such unexpectedly large numbers, however, he is optimistic that with the cooperation of the Consulting Faculty, the job can be done. The project's main thrust will now be the instruction of community physicians in the education and management of patients with earliest manifestations of chronic obstructive pulmonary disease.

The first meeting of the Faculty for the project to set up the details of the curriculum for physician training is scheduled for February 4.

Approval of this project has been indicated by the California Chapter of the American Society of Chest Physicians who presented Dr. Hallett with a check for \$1,000 to be used for the project as he sees fit. Another handsome contribution of \$9,000 has been made by the TB and Respiratory Disease Assoc. of LAC to be used towards the salary of another physician to assist Dr. Hallett in the work of the project.
