MULTIPHASIC SCREENING AND UNIPHASIC ANSWERS

It has become dogma to decry single-test screening programs. All right-minded people agree that a major detection effort which did no more than measure blood pressure would be inefficient and wasteful. If we are going to screen people, let us do as many tests as possible in the time allotted.

This shot-gun approach to detection is often accompanied by a singularly precise rifle shot answer for therapy; thus, people who decry single-type detection will, at the same time, set up such single-purpose therapies as a smoking withdrawal clinic on one side of town, a diet alteration clinic somewhere else, a drug withdrawal clinic at some other point.

It seems that we are adept at pooling resources for treatment of acute disease, i.e., the hospital, but those processes that require a regimen of life for disease control or prevention are becoming increasingly fragmented.

The behavioral responses necessary to alter a life style in the hope of ameliorating a disease must have many things in common that would be best served by a one-stop service. The patient who smokes too much, eats too much, drinks too much, worries too much and exercises too little, should have multiphasic therapies as efficiently available as multiphasic screening.

This is a problem for all of us who give health care. The difficulties inherent in changing a person's life style are great and the capabilities for encouraging it should be kept together.

MISS WARR has just returned from Seattle where she completed 4 weeks of a Course on Planning Inservice Education for Coronary Care Nurses, offered by the University of Washington School of Nursing in cooperation with the U of Washington School of Medicine, Division of Cardiology. Each trainee was responsible for taking a case on a predesignated subject for presentation to the others in the class, and during the next three weeks, is expected to initiate the planning of

an inservice program for CCU nurses in their own area. A member of the Faculty will visit each student during this intival to provide guidance in planning the program which will then be presented for evaluation in a workshop to be held from May 4-8. This is the 5th session of this federally funded course, which has been attended by approximately 60 students. The data gathered during the sessions is to be collected and sent to Washington for evaluation and eventual publication. Our AREA V representative and a trainee from Jackson, Mississippi have been the only RMP personnel to take the course.
