## QUALITY OF CARE...

is being studied by a special task force of AREA V staff and members of the Professional Advisory Group who have been assigned to develop a working definition of quality of care which will delineate the boundaries within which further study can take place.

A preliminary statement regarding the role of AREA V in promoting quality of care, drafted by John S. Lloyd, PhD and David Odell, and presented to the Professional Advisory Group in May, suggested: "The aim of AREA V should be to increase the use of quality control of medical care by providers throughout the area. The means by which this should be achieved is through development of technical expertise on the part of program staff and Professional Advisory Group members, and by offering consultation and technical assistance to providers who wish to develop or improve the quality control of medical care delivered in their settings."

The document suggests that after quality care has been defined, a survey of literature be made to identify various standards, methods, and procedures which have been developed, followed by a survey of current work in progress within the boundaries of the definition agreed upon. The results of these surveys would be kept on file by AREA V and the extent of application of quality control of medical care in the Area would then be assessed. This data, once analyzed, would provide a picture of the extent to which quality control mechanisms are currently applied to AREA V and would also serve as a baseline against which to compare the extent of application in later years.

At that point, according to Dr. Lloyd and Mr. Odell, AREA V would be in a position to begin offering various forms of technical assistance in the development and application of quality control mechanisms to those providers who request it. Assistance could be in the form of direct consultation, seminars with selected groups, or in the form of a referral to one or more of the resources

identified earlier. The knowledge and information gained could, of course, be shared with other Areas of the California Region and other RMP's.

Dr. Lloyd reports that the task force has elected to carry out the literature search prior to reaching a definition of quality of care, and that this step has been completed. Although a definition of quality of care has not yet been agreed upon, there have been some interesting issues raised. For example, it was suggested that a definition of quality of care include those who do not enter the system, as well as those who do. Further, it was proposed that whatever activities are carried out in AREA V with regard to quality of care, consumers should be as much a target of the results as providers, and the definition of quality of care should be as applicable to community groups as to providers of care.

Appointed to the task force are: David Odell, (Chairman) Special Advisor, Health Care Administration; Lee Cady, MD (Special Advisor, Systems and Computers); Jose Carlos (Special Advisor, Health Needs of the Under Served); Dr. Barbara Solomon (Special Advisor, Social Workers); Henry B. Dunlap (Special Advisor, Hospital Administration); George C. Griffith, MD (Special Advisor, Cardiac); Jane Z. Cohen (AREA V staff member who is working with the Southern California Council of Free Clinics on their study of quality of care); and John S. Lloyd, who is staffing the committee.

### NEW DC REVIEW PANEL IN ACTION

Proposals for the current cycle of developmental component funding were reviewed on August 22 by the newly appointed AREA V DC Review Panel which has undertaken to perform this task for a year (three cycles). Bertell W. Ferguson, DDS, was elected chairman of the group which parallels the Regional DC Review Panel. The Panel is composed of three members of the AREA V Advisory Council: Sol Bernstein, MD; Bertell W. Ferguson, DDS; and Lillian O'Brien, RN. Three members of the Professional Advisory Group: Stanley Gunstream, PhD; George C. Griffith, MD; and Dr. Barbara Solomon, ACSW--and two staff members--Dorothy E. Anderson, MPH, and Teresita P. Moreno, ACSW. John S. Lloyd, PhD will staff the committee. The three proposals that were reviewed were: "Aide to LVN Program; Nursing Career Ladder Linkage." "Training Program for Medical Social Work in Acute Hospitals." "Los Angeles Free Clinic: Utilization of Retired Medical Professionals." The committee will report its recommendations to the AREA V Advisory Council at its next meeting.

Mrs. Fletcher will direct a new AREA V project which, after assessment of the state of continuity of patient care in various districts of AREA V, will invite the participation of a selected number of hospitals in the presentation of workshops designed to improve continuity of care. Efforts will be made to have continuity of patient care training efforts included on an ongoing basis in the regular offerings of existing continuing education mechanisms.

For the past year, Mrs. Fletcher was community health nursing consultant for the Department of Social and Health Services, State of Washington. Prior experience in AREA V includes consulting services with the Visiting Nurse Associations of Pomona-West End, and of Pasadena and San Gabriel Valley; Director of Nursing Services for Brea Hospital Neuropsychiatric Center; Assistant Professor, Department of Nursing, and Coordinator of Public Health nursing faculty at Cal-State; Assistant Director of Public Health Nursing for San Bernardino County Health Department. She received her BS from the University of Minnesota School of Public Health and MS from the School of Nursing at UCLA.

Mrs. Gail M. White represented AREA V at the July 24-25 workshop "In-Home Services--Strategies for Community Planning." The meeting was co-sponsored by the California Association of Home Health Agencies and the U. S. Public Health Service, HEW Region IX. The 50 participants at the Los Angeles Conference were from Southern California and Arizona. Another session was held in San Francisco for Northern California and Nevada.

The purpose of the invitational workshop was to exchange ideas and information on existing programs and to discuss approaches for the inclusion of home care in the Comprehensive Health System of the community. National directions were described by Claire F. Ryder, MD, MPH, Chief of the Home Health Branch of the Division of Health Resources, Community Health Service, HSMHA, and by Brahma Trager, Health Care Consultant, San Geronimo, California. Also discussed were relationships of in-home services to other parts of the health care delivery system, to emerging HMO's and to various governmental agencies. Cluster sessions involved participants in identifying some problems and solutions related to in-home services.
