New MARC 21 Values/Fields: Summary

INTRODUCTION- APRIL 2000 TAG TABLE CHANGES

This document summarizes changes to the LC ILS Tag Tables (LCMARC21 and HLASMARC21) made available in April of 2000. In most cases the changes are newly implemented elements incorporated into MARC21 since LC's implementation of the ILS in August 1999 (changes implemented at that time and documented in the first version of this BWTD are retained as Appendix 1). Although these data elements are now valid in the LC ILS, not all of them will be actively supplied in LC cataloging (they may occur as "pass through" data elements in records done as copy cataloging). In general, this BWTD summarizes the subset of newly available data elements from two aspects: 1) those to begin actively supplying; 2) those NOT to supply (those not actively supplied should be considered "pass through" data elements). This summary is relevant to general cataloging (all cataloging for the data elements NOT to supply). Application of newly available data elements relevant to cataloging done in the special format divisions will be determined by staff in those divisions, as will the guidelines for their application.

Staff should evaluate any customized templates and/or macros they may have developed to determine if these changes have an impact.

5. CHANGES TO THE MARC COUNTRY CODE LIST

Two changes have been made to the 008 "Place of Publication" drop down list found in the cataloging module:

- ai, the obsolete code for Anguilla, has been removed from the tag table (ai for Armenia (Republic) remains); this change allows staff repeatedly hitting the "a" key to progress through the list of language codes.
- 2) **mh**, the code for Macau, has been annotated to indicate that after June 1, 2000 the use of the code is obsolete (will be covered by the code "cc" for China after that date).

APPENDIX 1. LC ILS DAY 1 CHANGES

During the time the MUMS system was nearing the end of its service, there were data elements related to updates to the MARC 21 (then USMARC) formats that were not incorporated into MUMS. Although these data elements are now valid in the LC ILS, not all of them will be actively supplied in LC cataloging (they may occur as "pass through" data elements in records done as copy cataloging). In general, this BWTD summarizes the subset of newly available data elements from two aspects: 1) those to begin actively supplying; 2) those NOT to supply. Consider other newly available data elements not listed here as "pass through" data elements. This summary is relevant to general cataloging (all cataloging for the data elements NOT to supply). Application of newly available data elements relevant to cataloging done in the special format divisions will be determined by staff in those divisions, as will the guidelines for their application.
