

### The Issue: ADIZ Established

- → Hastily Imposed Rule via Notice to Airman (NOTAM), restricting access around Washington, DC
  - ➔ Initially established as *temporary* emergency action 2/03
  - → New York initially too, but quickly rescinded
  - → No coordination with airspace users before establishment

# Washington ADIZ Rulemaking

- → FAA Published NPRM August 4, 2005
  - → Make the temporary restrictions permanent:
    - → File flight plan, Transmit discrete code, Talk to ATC
  - → More than 22,000 comments opposing
  - → Four Public Meetings hosting 600 pilots, Airport & Business Owners attended

# **ADIZ Facts**

- → ADIZ has imposed significant economic costs on general aviation and has increased the administrative burden on the FAA.
- → Government has never provided a specific, intelligencebased threat assessment to justify the design and specific procedures of the ADIZ.
- → Government has provided no evidence or analysis demonstrating that the ADIZ results in any measurable increase in security.

# The Impact...

- → Operational Requirements Discourage Flying
  - → 16% of ADIZ Stopped Flying
  - ✤ Top Concern Potential Violation of Procedures
- → \$43 Million Annual Loss at ADIZ Airports
- → Pressure on airports to close



# **AOPA Member Recommendations**


- → Replace ADIZ with National Security Area (NSA)
  - → Maintain 15-nm Flight Restricted Zone around Capitol
  - Activate ADIZ only for High or Severe Threat level

#### OR

- → Reduce Size of covered area to 20 miles
  - → Eliminates number of airports impacted
- → Eliminate the flight plan requirement
- → ATC procedures and new control tower for Montgomery County Airpark

# Leesburg (JYO) Procedures

- Leesburg code (1227) arriving/departing ADIZ
- Hust comply with published speed limit
- Announce Intentions via radio
- Inter-ADIZ operations require full compliance
- Reduce pilot & controller workload
- → Increases safety
