SPEAKER BIOGRAPHIES

Debbie Reed

President, DRD Associates

Debbie Reed is the President and Director of DRD Associates, providing strategic and policy support for national environmental, energy and agricultural groups on agricultural mitigation strategies for state and federal global climate change policies.

Reed previously worked for President Bill Clinton at the White House Council on Environmental Quality as the Director of Legislative Affairs and Agricultural Policy for the Climate Change Task Force. Prior to that, she was a Senior Legislative Assistant for U.S. Senator Robert Kerrey (D-NE), where she handled environmental, natural resource/ agriculture, and energy issues.

Reed has graduate and undergraduate degrees in nutrition, communications, dietetics and chemistry.

Bob Young

Chief Economist, American Farm Bureau Federation

Bob Young joined American Farm Bureau Federation in 2003 as the Chief Economist, coordinating the activities of the Economic Analysis Team.

Prior to coming to Farm Bureau, Young was Co-Director of the Food and Agricultural Policy Research Institute (FAPRI) from 1991 through 2003. He also served as an associate professor in Agricultural Economics at the University of Missouri. He was active in the development of the 1990 Farm Bill as well as various budget and disaster assistance bills.

Young has a Ph.D. in Agricultural Economics, and a B.S. and M.S. in Atmospheric Sciences from the University of Missouri.

Barbara Stauffer

Exhibition Developer, Dig It! The Secrets of Soil

Barbara Stauffer has been developing exhibitions at the Smithsonian's National Museum of Natural History since 1990. Ms. Stauffer is particularly interested in exhibitions that illuminate past and present global biological, environmental and cultural connections, change perceptions of the natural world, and explore the intersection of art and science.

Stauffer received her B.A. in History from the University of Virginia and a M.A. in Cultural Geography from The George Washington University.

Patrick Megonigal

Senior Scientist, Smithsonian Environmental Research Center

Pat Megonigal is the Lead Curator of *Dig It! The Secrets of Soil* and Chair of the Wetland Soils Division of the Soil Science Society of America. His major research interests are in soil carbon cycling, microbial ecology, global change, and wetland ecosystems. Megonigal was Assistant Professor of Biology at George Mason University before joining the Center in 2001.

Megonigal holds a PhD in Biogeochemistry from Duke University.

Bob Stephenson

Director, Farm Service Agency Conservation and Environmental Programs

Bob Stephenson is the Director of the Farm Service Agency's (FSA) Conservation and Environmental Programs Division (CEPD). His responsibilities include the Conservation Reserve Program, the Conservation Reserve Enhancement Program, and the Emergency Conservation Program.

Stephenson previously served as CEPD's Deputy Director; Deputy Director of the Southwest Area; Staff Assistant in the Midwest Area; hearing officer with the Agency's Appeals Staff; and the County Executive Director of the Decatur County FSA office in Indiana.

After graduation from the Indiana University School of Business, he returned to his family's grain farm until joining the Department of Agriculture in 1984.

Dale Hall

Director, U.S. Fish and Wildlife Service

Dale Hall has served as the Director of the U.S. Fish and Wildlife Service since October 2005.

A career Fish and Wildlife Service employee, Hall previously served as Regional Director for the Service's Southwest Region in Albuquerque, New Mexico. In that capacity, he was responsible for directing the Service's fish, wildlife, and habitat conservation, protection, and enhancement activities in Arizona, New Mexico, Texas, and Oklahoma. He is the author of numerous published papers on wetlands and fisheries ecology, and has also taught courses on wetlands identification and delineation.

Hall received a Bachelor of Science degree in biology and chemistry from Cumberland College and a Master's degree in fisheries science from Louisiana State University.

Dana York

Associate Chief, Natural Resources Conservation Service

Dana York was selected as the first female Associate Chief for NRCS in August 2004. In the associate chief position, she manages the agency's overall programs and operations, including a \$3.2 billion annual budget.

York began her career with the former Soil Conservation Service (SCS) as a student trainee. She has held various positions with the agency in Tennessee and Ohio, including soil conservationist, district conservationist and deputy state conservationist.

York is a native of Tennessee and received a Bachelor of Science degree in Agricultural Science from Tennessee Technological University and a Master's degree in Industrial/Organizational Psychology from Middle Tennessee State University.

SPEAKER BIOGRAPHIES

Gary Mast

Deputy Under Secretary, Natural Resources and Environment

Gary Mast was named USDA Deputy Under Secretary for Natural Resources and Environment in February 2007. As Deputy Under Secretary, Mast oversees NRCS and works closely with NRCS Chief Arlen Lancaster and Under Secretary Mark Rey.

Prior to joining USDA, Mast served as President of the National Association of Conservation Districts. He has been a Soil and Water Conservation District supervisor from 1981 to 2005 and was President of the Ohio Federation of Soil and Water Districts from 1995 through 1997. He is a sixth-generation farmer on his family's Ohio dairy farm.

Mast received a BA in Biology from Malone College in Ohio.

Ed Schafer

Secretary, U.S. Department of Agriculture

Ed Schafer was sworn in as the 29th Secretary of the U.S. Department of Agriculture in January 2008 and brings with him a record as an innovative two-term governor of North Dakota along with extensive private sector experience.

Schafer has had a lifelong interest in conservation. He helped arrange the U.S. Forest Service's May 2007 purchase of the Elkhorn ranch in North Dakota, site of President Teddy Roosevelt's 5,200-acre cattle ranch. Before entering public life, Schafer was an executive with the Gold Seal Company in Bismarck, a successful marketer of nationally-known consumer products.

Born and raised in Bismarck, North Dakota, Schafer graduated from the University of North Dakota in 1969 with a Bachelor's degree in Business Administration and earned an MBA from the University of Denver in 1970.
