Chairman Collins announced that two proposed action items on the agenda had been withdrawn; the Farmer-owned Ethanol Protection proposal and the Cattleguard proposal.

A motion was made and seconded to adopt the following resolution:

RESOLVED, that Docket No. CI-Silage Sorghum Pilot -04 -03, (Exhibit No. 2729), authorizing implementation of the Silage Sorghum Pilot plan of insurance with the following changes: (1) the coverage level is limited to 75 percent; (2) the price election is limited to 80 percent of the price election for corn silage; and (3) the policy should specify that grazing varieties are not insurable, with reinsurance, risk subsidy, and administrative and operating subsidy in amounts and under such terms and conditions as determined appropriate by the Manager beginning with the 2005 crop year and continuing through the 2008 crop year as authorized under sections 508 and 523 of the Federal Crop Insurance Act, is hereby approved. AND BE IT FURTHER RESOLVED, That the Board delegates to the Manager the authority to make such technical policy changes as are necessary to make the policy legally sufficient.

The Board voted unanimously to adopt the resolution.

A motion was made and seconded to adopt the following resolution

RESOLVED, that Docket No. CI-AGR-Lite-04-01 (Exhibit No. 2731), authorizing the expansion of the Adjusted Gross Revenue-Lite (AGR-Lite) Plan of Insurance to all counties in Alaska, Idaho, Oregon, and Washington, provided that actuarially appropriate premium rates, as approved by the Manager of the Federal Crop Insurance Corporation (FCIC), are provided by the Pennsylvania Department of Agriculture and the Washington State University Extension Western Center for Risk Management Education, beginning with the 2005 crop year, as authorized under section 508(h) of the Federal Crop Insurance Act, is hereby approved.

The Board voted unanimously to adopt the resolution

A motion was made and seconded to adopt the following resolution

RESOLVED, that Docket No. CI-AGR-Lite-04-02 (Exhibit No. 2732), authorizing the expansion of the Adjusted Gross Revenue-Lite (AGR-Lite) Plan of Insurance to all counties in North Carolina, provided that actuarially appropriate premium rates as approved by the Manager of the

In other business, Chairman Collins announced the withdrawal of the Whole Farm Revenue Protection Plan by Mike Duff of Agri-Services L.L.C. It had been tabled at the request of Mr. Duff in response to a notice of intent to disapprove on October 29, 2003. Although Mr. Duff expressed his intent to revise the submission in answer to the Board's concerns, he later decided to withdraw the product.

There being no further business to come before the Board, the meeting adjourned at 11:25 a.m., to meet again in July 2004 in Washington, D.C.
