The Board next considered Docket No. CI- GRP Rangeland New Index Pilot Crop Insurance Program – 08-01.

Ron Lundine (RMA) reported that the GRP Rangeland New Index Pilot Program that replaced the GRP Rangeland Pilot Program beginning with the 2005 crop year was evaluated in 2008. It was determined that the Net Hay Production Index mechanism in the program resulted in variable treatment of producers across counties because the index does not consistently represent actual rangeland forage conditions. Payments to producers were also found to be inconsistent within county rangeland forage conditions.

Chairman Glauber offered the following resolution which was seconded for adoption:

RESOLVED, that pursuant to the information contained in Docket No. CI- GRP Rangeland New Index Pilot Crop Insurance Program - 08-01, Exhibit No. 2948, as well as other related materials that may have been submitted to the Board for consideration and discussion on this matter, the Board approves the continuation of the GRP Rangeland New Index Pilot Crop Insurance Program, in the state of Montana, on a pilot basis until the Office of Management and Budget determines that the Department of Agriculture has sufficient funds to satisfy the pay-go requirements for implementation of the Pasture, Forage, Rangeland Rainfall Index plan of insurance, with reinsurance, risk subsidy, and administrative and operating subsidy in amounts and under such terms and conditions as determined appropriate by the Manager as authorized under section 522(c) and 523(a)(4)(b) of the Federal Crop Insurance Act, is hereby approved. AND BE IT FURTHER RESOLVED, That the Board delegates to the Manager the authority to make such technical policy changes as are necessary to make the policy legally sufficient.

The Board voted to approve the resolution. (Exhibit 2948)

The next action item before the Board was Docket No. Cl-Docket No. Cl- Silage Sorghum Pilot Program- 08-01. Chairman Glauber called upon Tim Hoffman of RMA to brief the Board regarding the Pilot Program.

Tim Hoffman stated that the Sorghum Silage Pilot Program was approved by the Board for 2005-2008. In 2007, significant revisions were made to the program by RMA under the direction of the Board. An evaluation of the pilot was completed in 2008, which suggested either termination or continuation with modifications.
