Report Highlights:

Recent weather events, which have arrived in the middle of the 2008/09 winter cereal harvest, have been seen as a cruel blow to Australia's winter cereal crop which is set to provide substantial rebound on last year's drought-affected crop, despite being grown on below-average rainfall.

Includes PSD Changes: No Includes Trade Matrix: No Quarterly Report Canberra [AS1] The month of November provided above average rainfall for most of the Australian continent, including cropping regions in southern Australia. Northern New South Wales and southern Queensland experienced some of the heaviest rainfall, and in these areas flooding and high winds were experienced. Southern NSW has also received significant rainfall.

Recent weather events, which have arrived in the middle of the 2008/09 winter cereal harvest, have been seen as a cruel blow to Australia's winter cereal crop which is set to provide substantial rebound on last year's drought-affected crop, despite being grown on below-average rainfall.

Heavy rains in November, arriving after harvest had begun, is likely to have caused damage to the remaining winter cereal crops yet to be harvested. At this stage, abandonment of winter cereal crops is yet to be realized; however downgrading of the remaining wheat and barley crops in the areas worst affected by rainfall is now likely.

Poor weather has also created large scale logistical issues for the Australian winter cereal harvest. Post is hearing reports of shortages of labor and harvesting equipment which has created a sense of urgency to harvest the remainder of the crop.

Post advises that, in the past, downgraded winter cereal crops have been utilized by the intensive feeding sector (dairy, lot fed cattle, pigs and poultry). Downgrading of significant quantities of winter cereal crops traditionally places downward pressure on exports of wheat and barley and boosted domestic livestock consumption.

On the positive side, widespread rainfall for the month of November has greatly boosted the prospects of summer crops such as sorghum and cotton. Sorghum, which can be planted from October through to early February, will likely receive a boost in area and yield (for the 2009/10 crop) following above-average rainfall in November. Falling grain prices, particularly for feed grains, may partially constrain increases in area planted to sorghum. Cotton, which largely had concluded planting when rainfall was received, has a greatly improved yield outlook (for the 08/09 crop) as a result of above average November rainfall. As a result of above-average rainfall in November, post believes a decline in average crop quality for the 2008/09 winter cereal crop is highly inevitable. Lower crop quality may constrain exports of winter cereals on the east coast of Australia and boost domestic livestock consumption, although this remains to be seen. Post also expects some increase in area and yield for the 2009/10 sorghum crop (although somewhat constrained by falls in price) and significant increases in yield for the 2008/09 cotton crop as a result of above-average rainfall in November.

Going forward, post expects sustained downward pressure on feed grain prices. A record 2008/09 sorghum harvest and improved prospects for the 2009/10 sorghum crop combined with the much larger 2008/09 winter cereal crop is likely to increase grain supply generally. Moreover, increased supply of feed grain due downgrading of some winter cereal crops is also likely to boost supplies of feed grains for the foreseeable future and will likely benefit intensive livestock feeders going forward.
