There are over 3.36 million acres of public land and it is divided into two Resource Areas: Three Rivers Resource Area, roughly 1.68 million acres in the northern portion of the District; and Andrews Resource Area, 1.68 million acres of public land in the south. Within the District boundary there are also large areas of private, other Federal and State lands.

"Kenny's excellent consultation and communications skills will serve him well in working with stakeholders associated with key Burns District resources and programs, such as the Steens Mountain Cooperative Management and Protection Area," continued Shepard.

Kenny McDaniel has been with the Federal Government since 1978 and held a variety of roles with the BLM including: Field Manager, Acting Deputy State Director-Division of Resources, Forester-Senior Specialist in the Washington Office, Natural Resource Staff Administrator, Forester, and Lead Forester in Medford.
