## **CDC Prepares with "Get Ready" All Hands Meeting**

At CDC, *the countdown is on*! In preparation for UFMS "go live," April 22<sup>nd</sup>, CDC's Financial Man-

agement Office (FMO) held an All Hands meeting on Friday, March 4<sup>th</sup> to share and discuss critical information regarding project status, expectations, and essential activities for the final days before system deployment.

Dr. L. Casey Chosewood,
M.D., from the Office of
Health and Safety, described how changes, like
UFMS, can be exciting and

## Getting Ready: UFMS and iProcurement Training at FDA

With Go-Live just around the corner, the FDA UFMS Training team is moving at full speed to get users ready for the implementation of UFMS and iProcurement. The training includes several phases for both UFMS and iProcurement users.

Phases of training for UFMS Users:

- 1. On-line prerequisites
- 2. Module-specific online courses using OnDemand
- 3. Classroom and web conference training

Phases of training for iProcurement Users:

1. On-line prerequisites

- 2. Satellite broadcast
- 3. Classroom training

At this time, all UFMS and iProcurement users at FDA should have received instructions for completing the prerequisite training. OnDemand courses for UFMS Users of the Accounts Payable and Budget Execution modules will be released this week for completion.

The UFMS Team has completed the schedule and class assignments for UFMS classroom training. Management has been notified of the schedule to enable necessary planning. The classroom schedule and assignments for iProcurement training

are currently being finalized and will be communicated as soon as they are ready.

After classroom training, users will be invited to schedule time with Super Users and Master Users to complete supplementary lab exercises. Some Learning Labs have been established and are already operational. There is a lab available in the Parklawn Building, room 11-90.

There are also labs at NCTR and in Chicago, Little Rock, and Dallas, with the planned addition of labs in Atlanta, Nashville, Irvine, Buffalo, Stoneham, and Jamaica.


## Stabilization Period - Operations and Maintenance Team (O&M)

The Operations & Maintenance Team is responsible for making the transition from the legacy financial management systems to the UFMS as seamless as possible for users, vendors, and financial management teams. Over the past four months, the O&M Team has formulated a plan to stabilize UFMS operations after go-live. This plan is designed to minimize the length and severity of the productivity dip normally experienced after major systems implementations (see graphic to the right).

The Operations and Maintenance Team, also known as The Stabilization Team, was assembled to manage the business operations of the Unified Financial Management System (UFMS). The Program Support Center (PSC) is the service provider of this function. This team is responsible for establishing and executing UFMS Stabilization policies and procedures for operating and maintaining the system. In addition, the O&M Team has developed UFMS standard operating procedures (SOPs) and will ensure that the production and disaster recovery sites are processing transactions consistently. The cross-functional Global Support Team (GST) was formed in March 2005 to provide comprehensive UFMS support. PSC has retained BearingPoint to manage and support both the UFMS applica-

tion and disaster recovery business processes during the Stabilization phase of the project.

The Centers for Disease Control (CDC) and the Food and Drug Administration (FDA) OpDivs will host Level 1 and Level 2 help desks to assist UFMS users. UFMS users will also have online access to self-help materials such as Frequently Asked Questions (FAQs) about UFMS.

about the Support Workforce Assistance Team (SWAT), which will be available on-site to help users with any difficulties. She introduced SWAT members and explained that they will be at several centralized locations within FMO, and also accessible by phone through the CDC Management Information Systems Branch (MISB) help desk. She stressed the importance of not being afraid to ask for help and closed by reminding FMO to "get trained" via

formal training classes currently in place, be ready for key dates, and share in the excitement!

The All Hands meeting concluded with personal UFMS testimonials delivered by several FMO team members. Johnny McGahee described several functional improvements he has noticed by being a part of UFMS testing and conversion. Nettie Berry recalled her first UFMS experience when she stated, "I don't think I will like

it," but with training has become more comfortable and believes UFMS will improve her job. Boyd Browning continued to build the excitement by sharing a UFMS poem that he had written (see page 2), 'Oh my goodness, UFMS is here'! If the SOPs, the FAQs, and the OpDiv help desks' Level 1 and Level 2 cannot provide an answer to a user's question, it will then be forwarded to the GST, which will be the ultimate source for Level 3 issue resolution. From a technical infrastructure perspective, the production UFMS environment is hosted at CDC's Mid-Tier Data Center (MTDC) and the associated disaster recovery environment is hosted at PSC's Information Technology Service Center (ITSC).

Finally, the O&M Team is responsible for managing changes to the UFMS. Two change management boards, the Change Review Board (CRB) and the Change Control Board (CCB), will be responsible for reviewing and implementing all proposed changes. The CRB will perform the initial review of a proposed change, including both its technical feasibility and its budgetary impact, and provide a recommendation to the CCB. The CCB will ultimately be responsible for providing final approval for all changes to UFMS. ■
