Reports:

Extension-Dr. John Jett gave the West Virginia University Extension Report as follows:

-An invitation was extended to attend The West Virginia Botanic Garden, Inc.'s Gateway to the Garden Celebration to be held June 23, 2007.

-The new manual is almost finished. Changes should be a chapter on Agrability and the ability to upgrade older manuals. The targeted price is \$65.00 and a CD may be available.

-A leadership conference was held at Jackson's Mill and a system of statewide reporting of Master Gardener hours was discussed.

-Information was distributed to order Fine Gardening Magazine, who will donate \$10.00 to the West Virginia Master Gardener Association for any new, paid 1,2, or 3 year subscription ordered.

Jennifer Williams, Extension Associate Professor of the Agriculture and Natural Resources Department, thanked the Master Gardener Association for the donation made toward John Jett's travel and announced changes in administration of Mike Garrison, President Elect, and the new Director of Extension, Dave Miller. She also discussed the program review of the Agriculture and Natural Resources Department.
