# House and Senate Hearings on OHV Management

The House Natural Resources Committee, Subcommittee on National Parks, Forests and Public Lands, held an oversight hearing on "The Impacts of Unmanaged Off-Road Vehicles on Federal Land" on March 13, 2008. Joel Holtrop, Deputy Chief for the National Forest System, testified on behalf of the Forest Service. Three panels provided testimony. ## **Motor Vehicle Use Map Production**

The National Map Team has completed their review of suggestions from the regions for improvements to the Motor Vehicle Use Map. They are working on implementing many of those changes and updating the Production Guide in time for FY 2009 maps. Some changes that will improve the map may be implemented by the field sooner. These changes will be identified in a letter from the Washington Office in approximately the next 30 to 60 days. ## **GAO Engagement**

In March, the Government Accountability Office (GAO) began a review of OHV use on Federal lands. As part of the first phase (which is designing the review), they conducted an entrance interview in the Washington Office in March and visited the Cleveland National Forest in early April. The review will address trends in OHV use; reported environmental, human health, and safety impacts; allocation of resources for enforcing OHV-related laws and regulations; and related enforcement challenges.

## **Updates From the Field**

The State of Colorado recently passed legislation that will assist the Forest Service in enforcing route and area designations for motor vehicle use. The law allows State peace officers to enforce those designations. For more information, contact Chris Sporl at 303-275-5168.

## **Public Participation Rapid Response Team**

A national Public Participation Rapid Response Team was recently formed, composed of members from a number of regions, all levels of the agency, and the U.S. Institute for Environmental Conflict Resolution.
